STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit HR.B.1 (Competitions, Selections & Secondments) deals with a wide range of human resources policies covering various aspects of a staff member's career. We are responsible for (1) organising and running competitions and selections as well as handling the relations with EPSO, (2) running the Junior Professionals Programme and (3) managing career-related events for statutory staff and running the programme for seconded national experts (SNE) and national experts in professional training (NEPT).

WE PROPOSE

Do you want to play a role in running the Commission's selection processes? If yes, we propose an interesting position as a **Data & Statistical Analyst** at the intersection of data analysis, statistics, IT developments and HR selection processes.

The successful candidate will support the team in ensuring the quality, robustness and transparency of data underpinning selection procedures. You will contribute to the continuous improvement of analytical tools and workflows, including through the development of scripting and analytical solutions.

You will act as a reference point for statistical and analytical matters within the team. You will support evidence-based decision-making and help ensure the reliability of competition results.

This role requires close collaboration with operational teams, selection boards and IT stakeholders. You will work in a dynamic and evolving environment.



Key duties include:

- Processing, analysing and validating datasets related to selection procedures, ensuring accuracy, consistency and methodological soundness
- Advising and applying appropriate statistical methods and data modelling techniques to support the analysis and interpretation of selection results
- Developing and maintaining technical solutions and tools (notably using Excel macros and programming languages such as Python) to improve efficiency and reliability of workflows
- Contributing to development of IT solutions supporting HR selection processes
- Contributing to knowledge sharing by drafting and updating practical guidance and templates as well as providing support to colleagues on the use of statistical tools and interpretation of standard indicators.

WE LOOK FOR

We are looking for an analytical and motivated professional with a sound quantitative background. You combine solid technical expertise with clear communication skills and a pragmatic, solution-oriented mindset. You are comfortable working with complex datasets and operating in a dynamic and evolving environment.

The ideal candidate has a background in statistics, data science, engineering, mathematics, psychology or a related field, with demonstrated experience in data analysis and handling sizeable datasets. A strong command of Excel (including complex formulas and the use of existing macros/templates) is required. Familiarity with basic scripting (e.g. running or adapting existing scripts) or similar technical solutions is an advantage.

In addition, the successful candidate should demonstrate the following key skills:

- Good analytical and problem-solving skills, with the ability to structure tasks, identify issues and propose practical solutions within established frameworks
- Ability to communicate data and results clearly to both technical and non-technical audiences
- High level of accuracy and attention to detail, ensuring consistent and reliable outputs
- Good organisational skills, with the ability to manage several tasks in parallel and meet deadlines
- Team-oriented approach and ability to work effectively with a range of stakeholders
- Proactive, service-minded attitude with willingness to learn, follow guidance, and share knowledge and good practices within the team



HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG III**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
