STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DGT.A.3.LT.2 is one of the two Lithuanian language units in the Commission's Directorate-General for Translation (DGT). It is based in Luxembourg. The unit specializes in the translation of communicative and legislative texts in an expanding number of fields, such as trade, social policy, education, health, and statistics. We translate into Lithuanian from primarily English and, to a much lesser extent, French. We are an entirely Lithuanian speaking unit, but we use English and sometimes French in daily contact with our colleagues from other language communities and horizontal units within the DGT. In addition, the unit is actively involved in terminology work, contributing to the consistency and precision of EU language. The Unit currently comprises twenty-four translators, a quality officer and five assistants, working together in a collaborative environment.

WE PROPOSE

The linguist agent will join a friendly, dynamic team and will work in a predominantly Lithuanian-speaking environment. The job consists of linguistic administrative tasks in translation management in DGT, using internal IT systems, tasks related to the treatment of translations (pre-processing and post-processing), quality assurance, documentary research, terminology support as well as more traditional secretarial administrative tasks using MS Outlook, M365 Apps, and internal DGT software. The role requires regular communication with colleagues within the unit and other DGT teams. You will join a dynamic unit in Luxemburg and will have the opportunity to contribute to shaping this position in the unit over the coming years. We apply an active internal training policy. You will be working as part of a small team of linguist agents (assistants), and in close collaboration with the larger group of translators and the head of unit.

WE LOOK FOR

We are looking for an organised, efficient and motivated colleague who would actively contribute



to providing linguistic assistance to the translation process, as well as general administrative support to the unit's translation team and management. Excellent spoken and written Lithuanian (mother tongue level) is essential; very good knowledge of English is also required and knowledge of any other EU official language, French in particular, would be an advantage. IT proficiency is a must and knowledge of translation tools such as SDL Trados Studio would be a big advantage as would experience of preprocessing jobs for translation and finalizing texts for delivery. You should be able and willing to work in a multicultural environment and should be able to integrate into a team but also work independently and under pressure when needed. You should demonstrate excellent communication and interpersonal skills, enabling you to interact effectively with colleagues and stakeholders at all levels. You should be capable of managing multiple tasks simultaneously and of working efficiently under pressure, while consistently meeting deadlines and maintaining a high level of professionalism.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English/Lithuanian and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AD, AST or AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
