STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG Interpretation's "Conference Services" unit (DG SCIC.C.1) is the domain leader and centre of expertise for all matters related to conferences at the European Commission. It has a team of dedicated, dynamic and professional colleagues who provide advice and hands-on support for the organisation and management of Commission flagship virtual, hybrid and in-person conferences, including participant registration services. In line with its role as domain leader, the unit also manages the Commission's Events Database, a conference participants' registration platform, a framework contract for the provision of conference services, a conference Wiki, a conference helpline and leads a network of conference correspondents across all DGs.

Our registration team is in charge of setting up on-line participant registration pages, managing participant queries, supervising on-site accreditation for in-person conferences and managing participant satisfaction surveys as well as extracting and analysing statistics. It also manages the corporate tool for participant registration, including a conference app and a module for measuring the carbon footprint of a conference.

WE PROPOSE

A job in a friendly 4-person team. Most of our work is screen and e-mail based, but you will also be in the middle of the action when things get busy at the start of our events, where you will supervise the registration process on-site at conference venues. All our conferences are supported through strong teamwork and we flexibly help each other out whenever there is a need. The activities listed below are performed by all team members.

You will:

For the management of individual conference projects:

- Set up online registration pages and databases for conferences, send mass e-mails to participants



and be in charge of the day-to-day management of the database

- Before in-person conferences, prepare and print participant badges as well as prepare lists of participants.
- Manage on-site registration for in-person conferences, ensuring connectivity and functioning of IT equipment, supervising conference assistants at the registration desk
- If applicable, coordinate with contractors for transferring data and renting necessary equipment
- Follow up on software updates by testing and using new functionalities of our registration platform
- Ensure day-to-day management of participant requests for information and assistance
- Provide data analysis, create reports and statistics

For the management of the corporate participant registration tool:

- provide user support to Commission services using the corporate registration solution
- be involved in organising user training and user community activities across the Commission
- continuously learn about new features and functionalities
- liaise with Commission services to be aware of their needs in the field of participant registration and related areas of activity, as well as identifying ways to respond to those needs

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English/French.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
