STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate for Horizontal Policies is a friendly and dynamic Directorate organised into 4 Units, contributes to making finance work for everyone and to ensuring that the financial sector promotes EU and Commission priorities.

This includes developing strategic transversal policies for the financial sector implemented at the level of the Directorate General and in close cooperation with other Commission services, while also taking the international dimension into account.

More specifically, the Directorate is in charge of:

- completing and strengthening the capital markets union, to mobilise capital across the EU and channel it where it is needed most;
- ensuring that the European financial system supports the transition towards a sustainable economy;
- enhancing the quality of retail financial services and the functioning of the payment systems;
- fostering digitalisation of financial services and technological innovation.

WE PROPOSE

An opportunity to work in a stimulating and highly challenging work environment, where the selected candidate will act as a floater secretary within Directorate B – Horizontal Policies. The selected candidate could also be requested to help in any Unit across the Directorate in case of need. This job will give an opportunity to enrich one's professional experience with a variety of tasks and working methods. S/he would be given a broad range of secretarial and administrative responsibilities, such as:

- Assisting, together with the other Assistant, the Director, the Heads of Unit (HoU) and Unit members in all organisational matters, ensuring the follow-up of decisions and deadlines;



- managing the Director's or HoU's diary, filtering telephone calls and organising meetings;
- attributing correspondence, ensure the circulation of documents as well as document management;
- handling briefing requests for Director within the Directorate;
- organising missions and processing the related administration.

WE LOOK FOR

An enthusiastic, proactive and highly motivated professional secretary who is flexible, has excellent organisational and prioritising skills and can take on a variety of organisational, secretarial and administrative tasks. A friendly and helpful attitude is key, as well as the ability to anticipate the needs of the colleagues supported.

Interested in contributing proactively to the activities of the directorate, s/he will share information and be a good team player. S/he should have experience in document management as well as a sound knowledge of MS Office applications (Word, Excel, PowerPoint). Expertise in Commission tools would be an asset.

The successful candidate should also possess an excellent command of spoken and written English. A good knowledge of French would be considered an asset.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.



2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG II**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
