## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

The position offers candidates the possibility to become part of a dynamic, innovative and high-profile team in Luxembourg.

Over the last 5 years, the Commission has built up a professional debt management capacity resembling the operational capacities housed in national debt management authorities. This operational framework is deployed for mobilising the financing for a number of high-profile EU financial assistance programmes, notably NextGenerationEU and the most recent support programme for the Ukraine as well as SAFE.

These operations are now organised under a unified funding approach, including the related internal governance and risk management structures. The Commission's funding approach foresees the organisation of funding operations through a common pool, complemented with a dedicated liquidity and payment management. The funds are mobilised through different types of funding transactions and complemented by a professional investor relations and communications approach to liaise with investors and other market participants. A large share of the proceeds will be raised through the issuance of Green Bonds for which the Commission has established a dedicated Green Bond Framework.

The successful candidate will join the Directorate, which undertakes market operations on behalf of the Union budget ("Asset and Financial Risk Management"). This Directorate, the bulk of whose activities are located in Luxembourg, forms part of Directorate-General for Budget (DG BUDG).



## **WE PROPOSE**

---

The Unit is looking for administrative, organisational and financial management support in Luxembourg. The successful candidate will provide support to the Unit in the following areas:

- Coordination of payments related to disbursements under different financial assistance programmes;
- Support in activities related to funding transactions (EU bonds and bills), including management of documentation processes;
- Oversight of a dedicated administrative budget;
- Coordination of interactions with Credit Rating Agencies and other key stakeholders.

## **WE LOOK FOR**

---

The successful candidate should also have strong analytical skills, pay a high level of attention to details and have excellent organizational skills. Furthermore, given the need to frequently interact with other involved Commission services and external stakeholders, s(he) should also possess good communication skills (oral and written). Moreover, s(he) should also be able to perform her/his tasks independently, organize her/his work with a view to meet short deadlines and display team spirit and initiative. Experience in drafting reports and notes would be an asset.

The successful candidate should have a strong understanding of the financial operations managed by the Commission and be familiar with the main Commission procedures as well as the main office automation tools and IT applications (e.g. Ares, Basis, MIPS, Decide Consultation, Legiswrite). Prior experience in managing processes related to financial operations is required.

A very good command of English (written and oral) is required for this position. Knowledge of French would be an asset.

The post will involve a diverse and stimulating range of tasks. The successful candidate will be closely embedded in a friendly, dynamic and collegiate team.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission..

### **➤ Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1<sup>st</sup> contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
