## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

The Euratom Supply Agency (ESA) is established directly by the Euratom Treaty (Chapter 6). It has legal personality and financial autonomy while its staff are European Commission officials, administratively attached to the Directorate General for Energy. It is a small Agency with a staff of 17, headed by a Director-General appointed by the Commission and has a positive working environment.

The Agency's mission is to ensure the supply of nuclear materials and fuels to all users in the EU by means of a common supply policy. ESA also acts as a nuclear fuel market observatory providing the European Atomic Energy Community with expertise, information and advice on any subject connected with the operation of the market in nuclear materials and services.

ESA has a (small) budget of its own. The Financial Regulation applicable to the general budget of the European Union applies directly to the implementation of ESA's budget.

The Nuclear Materials and Fuel Market Unit, to which the position belongs, assesses contracts which pertain either to the supply of nuclear materials or to the provision of services in the nuclear sector, and prepares the final decisions of the Agency's Director-General on them. In addition, it monitors the nuclear fuel market and the supply of medical radioisotopes and on this basis prepares and issues several publications (e.g. weekly news briefs, quarterly and annual reports).

### WE PROPOSE

---

We are seeking to hire one Secretary – Administrative Support. This is an interesting and challenging job in a position providing operational and administrative support in the dynamic and friendly team of dedicated officials who work closely together in the Nuclear Materials and Fuel Market Unit.

The future jobholder will report directly to the head of unit and will also work closely with the Director-General of ESA and her/his team.



Contributing to the Agency's core missions, the position entails interesting and evolving tasks and is connected with ESA's role as a major actor in its field.

The selected candidate will be directly involved in the workflow of nuclear supply contracts by registration and preparation of files and their upload in a secure database.

S/He will be expected to initiate financial transactions for budgetary commitments and payments, monitor financial records and calculate reimbursement of expenses incurred in duty travels.

The selected candidate will handle the Commission inter-service consultations.

S/He will be involved in the preparations of meetings with external stakeholders.

The offered post is located in Luxembourg.

## **WE LOOK FOR**

---

We are looking for a motivated, discreet and trustworthy candidate who should have:

- Good command of standard office tools (Outlook, Word, Excel) and collaborative and hybrid working tools (MS Teams);
- Good organisational and planning skills;
- Accuracy, sense of responsibility and an eye for detail;
- Knowledge of the financial management procedures.

Experience on document management in the Commission environment, on handling of Sensitive Non-Classified and Classified documents and a command of IT tools for specific application areas (Sysper2, ARES, Decide, ABAC Workflow/SUMMA) will be considered as assets to have.

A good knowledge of two EU official languages, including English, French or German, is required. For this particular post, a very good command of English is essential.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and in another language (French or German).

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission. Candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

### ➤ **Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1<sup>st</sup> contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
