STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Energy is working to foster a competitive European economy, ensure energy security and accelerate Europe's clean and just energy transition to be the first climate-neutral continent by 2050. We set out policies to develop an innovative, resilient and integrated energy system, which delivers a continuous supply of affordable, secure, reliable and clean energy to its citizens and businesses in line with the President's Political Guidelines.

Energy stands at the core of the Clean Industrial Deal, a crucial component in achieving a competitive, sustainable, low-carbon economy and affordable energy through the transition to renewable energy sources, security of supply, energy efficiency, and the adoption of clean technologies. We strive to bring down energy costs and prices for consumers and remove barriers for energy transition and stimulate energy solutions that drive the shift to affordability and climate neutrality.

Unit ENER.E.4, Inspections: reactors, geological repositories and other facilities. The unit is part of the Directorate for Euratom Safeguards, in the Directorate-General for Energy. The Directorate enables the Commission to fulfil its duties under Chapter VII of the EURATOM Treaty; namely, to ensure, by appropriate control, that nuclear materials are not diverted from their intended uses and that safeguarding obligations, assumed by the Community under international agreements, are complied with.

The unit is responsible for the safeguards verifications of several hundred places in the European Union, where nuclear material is being held or used. Our core business are reactors, spent fuel stores, geological repositories, research centres and a multitude of other small installations. The safeguards objectives are mainly pursued by means of on-site verifications that consist of audit activities, on the one hand, and of physical verifications of the nuclear material itself, on the other hand.

Our unit has 40 staff and is organised in four teams, which cooperate seamlessly. The unit works in close cooperation with other units of the Directorate and with the International Atomic Energy



Agency (IAEA). We also cooperate with the Joint Research Centre (JRC), as well as with third parties at nuclear operator and Member State level. Our inspectors also provide back-up to and participate in inspections of the other inspection unit.

WE PROPOSE

We have a vacancy for an Euratom inspector, who will, as part of a small team under the supervision of a Team Leader, be tasked with implementing Euratom Treaty safeguards mainly in nuclear installations.

We propose a challenging job, where the core task is to prepare and carry out inspections at nuclear installations and establishing within reasonable time limits comprehensive technical reports and/or briefings on those inspections. This entails frequent missions.

The jobholder is required to work with confidential data and to represent the Commission during her/his contacts with the nuclear installation operators, representatives of the Member State authorities and international organisations, such as the International Atomic Energy Agency (IAEA).

The jobholder should have an interest in technical and scientific matters and a keen interest to learn the specificities of the domain. However, she/he does not have to be an expert to apply for this position, as we will provide extensive relevant training, job-shadowing and mentoring.

The jobholder has a certain autonomy in the execution of her/his tasks, as long she/he delivers on the unit's tasks and duties, according to instructions, and also performs a minimum number of inspections per year.

From time to time, she/he is expected to carry out/be part of missions of other teams covering different types of nuclear installations. She/he has the opportunity to work in a truly multicultural environment and to inspect in a large variety of places in the European Union.

WE LOOK FOR

We look for an Euratom inspector, with a technical and/or scientific background, who has related practical experience.

A good knowledge of two EU official languages, including English, French or German, is required. An excellent command (oral and written) of English is required.

The ideal candidate should be motivated, proactive, curious, observant and a good team player.

She/he should be capable to

- deliver on set objectives within the given time-frame;
- represent the European Commission competently in contacts with nuclear stakeholders;
- integrate swiftly in a team but also work independently;
- react promptly, flexibly and adequately to demands and changing circumstances;
- communicate clearly and professionally both orally and in writing;



- deal with legal and regulatory matters;
- understand, handle and interpret technical data;
- learn and apply technical and IT skills in a short period of time;
- solve problems pragmatically within the legal and administrative framework;
- adapt, especially during inspections, diplomatically to the respective cultural and industrial environment.

Inspection missions typically require the use of a rental car; the missions may sometimes require work outside normal working hours, on weekends or official holidays; therefore, the jobholder is expected to hold a valid driving license and to show flexibility with regard to working and mission time.

This position is "a category A exposed worker": her/his work involves a risk of exposure to ionizing radiation and contamination. Therefore, she/he is submitted to the operational radiation protection measures including specific training, individual dosimetry and monitoring, and medical surveillance. The short-listed candidate will be subject to specific medical checks performed by the occupational health service (Medical Service of the Commission) in order to determine whether she or he is fit to work in controlled areas. If the short-listed candidate is not declared fit to work in controlled areas, she/he will not be selected for this position.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and French.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission. Candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

➤ **Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function groups AD, AST or AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
