STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat's mission is to provide high quality statistics and data on Europe. Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

The Unit F.3 'Labour market and Skills' produce high-quality statistics on European labour markets and education, ensuring production and dissemination of statistical information needed to design, implement, monitor, and evaluate related policies in the European Union. In particular, the unit:

- provides comparable, reliable, and timely labour market statistics, including employment and unemployment rates, job vacancies, earnings, and labour costs, as well as education statistics from surveys to meet the needs of EU policymakers, and general public;
- contributes to the set of European Principal Economic Indicators with data on unemployment, job vacancies, and the labour cost index;
- continuously develops the necessary common statistical standards, methodology, and production processes for high-quality statistics on labour markets and education.

WE PROPOSE

Unit F.3 of Eurostat, responsible for labour market and education statistics is seeking to hire a Statistical Assistant. The successful candidate will join the Labour Market statistics on Businesses (LMB) team to ensure the timely production of quarterly Job Vacancy Statistics, annual Gender Pay Gap data and annual net earnings data and to prepare for the updated transmission programme under the revised LMB legislation. The team is composed of 6 persons and the working language is English.

The tasks of the Statistical Assistant consist of:

- Validating data and metadata transmissions;
- Preparing timely dissemination of data and indicators in the database of Eurostat;

- Drafting news releases, statistical articles and analysing trends in data;
- Managing IT systems relevant to the data treatment;
- Participating in innovative projects in the field;
- Maintaining contacts and exchanging information within Eurostat, other Directorates-General of European Commission and the European Central Bank
- Liaising with Member States as regards the harmonisation of statistical methods and procedures
- Preparing and participating in the meetings with internal and external stakeholders.

Contribution to methodological work, data analysis and indicators' production are included in the tasks of the Statistical Assistant. The new colleague will cooperate closely with the rest of the unit, with other units within Eurostat and with other parts of the Commission.

WE LOOK FOR

We look for a motivated colleague with at least a first experience in statistical production and dissemination, having analytical and organisational skills and who likes working in a team and is able to deliver individually and proactively.

The following qualities and experience are sought:

- Proven experience in statistical production
- Relevant educational background in statistics, economics, information technologies or other related field
- Knowledge and experience with statistical IT packages for data processing and analysis
- Strong teamwork and communication skills, with a proactive, solution-oriented mindset
- Service-mindedness, quick learning and a strong sense of responsibility
- Ability to deliver against strict deadlines and ability to effectively plan own time
- Good command of English

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the post;
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
