## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

---

BUDG/B/4 is responsible for the policy, implementation and control aspects of the Own resources of the EU budget. It inspects and verifies Member State's compliance with EU requirements for the correct, complete and timely collection of own resources (mainly customs duties) that are an important part of the EU budget. With this control part we also participate in policy preparation and development related to all EU budget resources (TOR, VAT OR, GNI, Plastics) and possible new OR.

### WE PROPOSE

A job of Policy officer for GNI, Plastics, Traditional Own Resources and for preparation of possible new own resources. In the same time inspector for Traditional own resources and policy officer dealing with Customs reform with a dynamic and varied work portfolio, including several missions in Member States each year. The job portfolio includes: Contributing to the all EU budget resources policy developments; EU Customs policy, the development of the Customs Union, and the protection of the EU's financial interests; Preparing, organising and carrying out on-the-spot inspections mainly for traditional own resources (TOR) to Member States under Article 2 of Council Regulation (EU, Euratom) 2021/768; Assessing administrative and accounting systems of Member States using audit techniques and tools; obtaining and evaluating sampled data from Member States to conclude on compliance, qualify the nature of any errors found, and propose ways to improve the national systems; Drafting mission reports and ensuring appropriate follow-up by Member States, including the assessment of Member States' financial responsibility for losses to the EU budget due to their administrative errors; Analysing write-off cases reported by Member States, draft subsequent correspondence, and ensure proper follow-up until closure; Analysing the Court of Auditor's Preliminary Findings letters together with related answers from the Member States and ensuring appropriate follow-up; Cooperating closely with other Commission services (DG TAXUD, OLAF, Legal Service, DG TRADE) and other institutions (EPPO); Presenting results of TOR inspections and Commission services' position on OR-related issues to Member States in Advisory Committee on Own Resources and occasionally in other committees, expert groups, and working parties;



## **WE LOOK FOR**

---

Candidates experienced with policy development that are naturally curious, interested in resolving complex cases, and have an eye for detail. Good knowledge of all the EU budget resources and possible new own resources, customs field and anti-fraud strategies and concrete work experience in these areas is very important. Practical experience in verifying/auditing customs and/or accounting systems and procedures, and data analysis would be an asset, same as having worked in direct contact with external stakeholders. Candidates should have good strategic thinking, organisation and communication skills, a sense of initiative and responsibility, and the ability to work both independently as leader of inspection team and as within a team. Good drafting skills, mainly in English, are required for the job.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### **➤ Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AD.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1<sup>st</sup> contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
