STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Compliance and Planning Unit of DG CNECT is a dynamic team of 37 staff members within the Resources and Support Directorate. DG CNECT is in charge of making Europe fit for the digital age. Through funding, legislation and policy initiatives, we help to ensure European leadership and independence in critical digital technologies (such as artificial intelligence, common data spaces, high-performance computing, 5G, micro-electronics, blockchain and quantum).

We aim to provide an integrated approach in the areas of compliance with rules and procedures, implementation of an effective internal control system, and are in charge of the public procurement files for DG CNECT.

The procurement team handles the procedural and financial aspects of all procurement procedures in the DG (large scale IT projects, studies, consultancy, external staff, conferences, catering, ICT equipment etc.) and payments. It is led by an experienced head of sector and composed of 15 colleagues, who carry out financial initiation and verification tasks linked to all types of procurement procedures.

WE PROPOSE

We propose an interesting position for a colleague who will handle secretarial tasks and is ready to take on additional responsibilities as finance and contracts assistant in the procurement team.

The position will consist of:

- monitoring the implementation of procurement procedures and payments, and ensuring follow-up and respect of deadlines,
- ensuring quality and consistency of financial and contractual data in/between different databases,



- checking functional mailboxes and forwarding emails to responsible colleagues within the team,
- providing assistance to operational units and colleagues on procurement procedures in particular for the very low value procedures and the specific contracts under simple framework contracts or in cascade,
- giving visa as financial initiating agent,
- preparing notes and financial correspondence using corporate templates.

The post sometimes requires working with short deadlines. There are frequent interactions with policy units. Proper back-up arrangements are in place and we complement each other in case of need.

WE LOOK FOR

We are looking for a dynamic, proactive, well-organised, open and committed team player, with good interpersonal and communication skills. University education is not required for this position.

The ideal profile for the job is:

- practical skills and hands-on professional experience, with at least 2 years of professional experience in administrative and/or financial tasks; professional experience with procurements being an advantage;
- comfortable in using digital tools and computer systems;
- very good organisational skills and a structured and result-oriented approach to work;
- a strong sense of client and service orientation;
- good interpersonal skills; we want you to contribute to our good team atmosphere with ideas and experience;
- good oral and written communication skills, in order to communicate efficiently with internal and external stakeholders;
- the ability to manage stress in a dynamic environment;
- an open mind and able to adapt easily to new situations.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
