STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit B3 in the Directorate-General for International Partnership (INTPA) is seeking to hire a Programme Manager for the European Commission Office in Greenland. The selected candidate will work as part of a five-person team in Nuuk, under the supervision of the Head of Office and INTPA Headquarters, contributing to the EU's growing strategic partnership with Greenland in a highly visible geopolitical and policy context.

WE PROPOSE

A varied and hands-on role combining programme management, policy engagement and communication. The post-holder will contribute to the analysis, conception, elaboration, implementation and monitoring of EU policies and cooperation programmes in Greenland in key sectors such as connectivity, green and blue sustainable economies, tourism, climate change and biodiversity as well as research, culture and other relevant sectors for the EU-Greenland partnership. The role includes engagement with Greenlandic and European authorities and stakeholders, support to policy dialogue and coordination with Headquarters and partners. The post will also include responsibility for the communication activities of the Office in close coordination with communication colleagues in Brussels and Copenhagen.

WE LOOK FOR

A motivated, proactive and energetic colleague with EU and/or programme management experience to support the European Commission Office in Greenland in the development and management of the EU-Greenland Partnership as defined by Council Decision 2021/1764.

The ideal candidate brings solid experience in international relations and programme management, ideally with exposure to EU-funded projects, budget support or financial instruments. You are adaptable, hands-on and thrive in fast-paced, evolving environments. You are aware of the conditions surrounding a posting in Nuuk, Greenland and motivated by the opportunity to be part of a small and dynamic team delivering tangible impact in a unique and dynamic setting.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.
For 3a contract agents working in a Delegation, who have recently taken up post, may be subject to additional restrictions according to Commission Decision C(2020) 997 final of 26.2.2020

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from [the EPSO database](#)⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Nuuk, Greenland**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 2 years**. The contract may be renewed in the interest of the service for a definite duration. If a second renewal of the contract is in the interest of the service, the contract will be for an indefinite duration.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
