STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Employment, Social Affairs and Inclusion Directorate-General (DG EMPL) pursues policy, legislative and financial initiatives to build a competitive social market economy in the EU by shaping and promoting a modern European social model.

Directorate C works towards promoting social dialogue and improving working conditions through effective labour law and safe and healthy working environments.

Unit C4's is the source of country intelligence for Spain and Malta for DG EMPL. Its mission is to contribute to attaining the aims and objectives of the European Pillar of Social Rights, support a fair recovery, green and digital transitions, and contribute to enhanced economic and social resilience in these countries. It promotes efficient and inclusive labour markets and social protection systems, supports skills development and accessible social services and healthcare for all. In close cooperation with the Member States authorities and various stakeholders, it ensures the programming and implementation of the European Social Fund (ESF) and Social Climate Fund (SCF).

WE PROPOSE

EMPL.C.4 is seeking a **Programme Manager** in charge of **monitoring the implementation of the 2021–2027 ESF programmes for Spain**. The role involves contributing to the effective use of the funds in line with the Commission policy priorities and to the compliance with their specific rules. You will analyse and process proposals for ESF+ programme amendments considering the funds' objectives, EU policies and EU semester's country reports. You will assess programme execution and performance, support the assessment of Simplified Cost Options and other simplification measures. You will also contribute to the process for the approval of the Social Climate Plans of Spain and Malta, and to monitoring their implementation.

As the negotiations on the next Multiannual Financial Framework progress, some engagement in the dialogues with Spain and Malta regarding the preparation of the National and Regional Partnership Plans for 2028–2034, including the regional chapters, is expected.



As Programme Manager, you will organise meetings with Member States and stakeholders. You will contribute to the dissemination of the results of cohesion policy, European Semester outputs, and other policy initiatives under the European Pillar of Social Rights. Finally, the role further includes the preparation of internal briefings, notes, and replies to inquiries from the European Parliament and citizens.

WE LOOK FOR

We are looking for a proactive and dynamic colleague with a strong commitment to social inclusion and poverty reduction, as well as a good understanding of programme management. The ideal candidate shall be able to perform a wide range of activities, as described in the job description, from detailed analysis, policy knowledge to good communication and drafting skills. An education background and experience in employment and social affairs and/or cohesion funds management, including the ESF+ legislation and EU financial rules, would thus be considered a strong asset.

The job requires strong organisational skills to work autonomously and deal efficiently with multiple tasks, including strong attention to detail, ability to be proactive and prioritise, ability to identify problems and propose solutions quickly, and keep up with deadlines. The job also requires the ability to liaise with counterpart across DG EMPL and beyond (whether policy or funding units) and cooperate effectively in a team. A high proportion of the tasks under this position will be implemented in English or Spanish.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.
