STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit C.1 supports the development and implementation of the Clean Planet Directorate strategy towards an integrated, sustainable and climate neutral European energy, transport and urban sector. The unit's aim is to accelerate the scaling up and deployment of innovative Clean Planet solutions and maximize synergies between Horizon Europe activities, as well as between Horizon Europe and other EU and national funding and financing programmes.

The unit coordinates the contributions of the Clean Planet Directorate to the Horizon Europe Strategic planning as well as the development and implementation of [cluster 5 activities](#). It is also responsible for the implementation of the Horizon Europe Mission on Climate Neutral and Smart Cities.

The unit builds bridges across DG RTD, interacting closely with other policy DGs and ensures an open and constant dialogue with the Member States, the research community, industrial stakeholders and relevant international partners for maximising synergies and impact of EU research and innovation.

The unit coordinates the communication and international cooperation activities for the Clean Planet Directorate including Mission Innovation.

WE PROPOSE

We propose a dynamic and challenging position as a policy and communication officer, contributing to the planning, development, implementation and monitoring of the Directorate's information and communication strategy, with a strong focus on its major policy objectives and the DG's broader research and innovation policies.



The policy and communication officer will provide advice and quality support to all units for the preparation of external and internal communication and information materials, ensuring coherence, alignment and high standards across outputs. This role also includes coordinating the dissemination of outcomes from EU funded projects to maximise their visibility and promote their use.

In close collaboration with the communication unit, the officer will play a coordinating role for the Directorate's digital presence, including the web and social media channels, ensuring consistent messaging and alignment with corporate communication priorities.

The officer will also support the design, implementation and follow-up of communication campaigns aligned with DG priorities, as well as the planning and coordination of key external communication activities and events related to research and innovation policies. He or she will liaise with other European Institutions (European Parliament, Committee of Regions, European Economic and Social Committee) and key stakeholders including DGs, Executive Agencies and Joint Undertakings, category associations, as well as act as the Communicating Research Implementation Group (CRIG) Member for the Directorate.

WE LOOK FOR

We look for a highly motivated, dynamic and innovative colleague with a service-orientated approach. The post requires a good capacity for planning and organisation, the ability to provide quick input, strategic intelligence and analysis, and to contribute to policy briefings for the hierarchy, as well as swift and sound responses to Commission services and external stakeholders. Excellent oral and written skills in English, allowing for effective communication with all counterparts and partners, as well as the capacity to establish solid collaborative working relations are essential. The successful candidate will also be capable of working independently and also as part of a wider team. Proven practical experience in communication, as well as strong skills and knowledge of the tools, together with a good knowledge of the Framework Programme for Research and Innovation are required. Experience in EU policy processes and the Commission's internal procedures would be an asset.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from [the EPSO database](#)⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances.
