STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

A dynamic and friendly unit within DG AGRI responsible for "Strategic programming, internal control and inter-institutional relations". The mission of Unit I.2 is to coordinate DG AGRI's relations with the European Parliament, the Council and other bodies and national Institutions, to implement strategic and performance programming, internal control and risk management, and to coordinate the relations with the Internal Audit Service.

WE PROPOSE

The successful candidate will be part of the secretariat of the unit and will provide administrative and secretarial support to the unit and to the Head of Unit. They will have to:

- attribute incoming mail (Head of Unit's Inbox and ARES) to appropriate colleagues
- inform DG AGRI colleagues of any document, meeting or information coming into the Council portal and distribute to appropriate colleagues
- manage the Unit functional mailboxes
- manage and support TEAMS – SharePoint online (internal to unit and for whole AGRI use)
- assist in dealing with briefings (BASIS) and inter-service consultations (DECIDE),
- manage missions (reservations and MIPS), absences and holiday requests (SYSPER2)
- compose and draft and prepare routine correspondence
- web editor for updating the unit website and the procedures website.

The jobholder will also contribute to coordinating replies to letters from Members of the European Parliament for which DG AGRI is lead or associated service. Moreover, s/-he will help with other administrative tasks specifically linked to the unit's responsibilities in the area of inter-institutional relations, such as the organisation of DG AGRI participation to Informal Council meetings.

The post requires good organisational skills and involves frequent contacts with other institutions,



central services, other DGs and with most units in DG AGRI.

WE LOOK FOR

We are looking for a proactive team player and highly motivated candidate, with a good sense of organisation, initiative and responsibility, and capable both of working independently and as a member of a small team. Frequent contacts throughout the DG and with external stakeholders are a normal part of the job, it is therefore essential to establish and maintain trust and good relations with all services.

The candidate will have good IT skills, including the use of SharePoint and Microsoft Teams. Ideally, the candidate will have proven experience with BASIS and with coordinating the preparation of briefings. It will be an advantage if the candidate has prior experience in inter-institutional coordination tasks as well as basic knowledge of or interest in Agriculture and Trade policies.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

FOR AST and AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
