STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of Unit EMPL.G.4 is to contribute to the sound and efficient management of the financial resources of DG Employment, Social Affairs and Inclusion in direct, shared and indirect management. The unit is composed of 46 staff members in charge of all financial implementation activities in the Directorate-General organised in four teams grouping different implementation modes.

WE PROPOSE

We propose a highly dynamic and challenging position of a Programme Assistant - Financial Initiation and Verification in a team dealing with several Funding programmes under the responsibility of DG Employment, Social Affairs and Inclusion.

The college will provide programme assistance, financial initiation and verification of grants transactions in direct and indirect management.

In addition, s/he will assist in the preparation of grant agreements, verification of the budgetary and legal commitments, analysis of the financial capacity of applicants, confirmation of the adequacy of the budget requests and verification of cost claims by the applicants as well as following up on results from audits. Furthermore, financial and operational monitoring of the implementation of projects under the programmes managed by DG EMPL as well as assessment and processing of amendment requests will be part of the new colleague's tasks.

The colleague will collaborate towards the implementation of the objectives of the unit by:

- supporting the operational units in the analysis of the detailed grant applications before the preparation of grant agreements;



- maintaining contacts with the applicants and the project coordinator to prepare draft grant agreements, including the verification of the project budget;
- assessing the adequacy of the project milestones, deliverables and proposed budget with the grant agreement of the action proposed by the applicants;
- ensuring the efficiency, effectiveness and economy of the applications by verifying the respect of the regulatory and programme requirements and compliance with the applicable rules and analysing problems during the life of the grant agreement and the need for amendments.

The new colleague will be in frequent contacts with colleagues from within and outside of the unit, at technical and management levels.

WE LOOK FOR

We look for a dynamic and motivated candidate with:

- knowledge in controlling or managing grants in conformity with the Financial Regulation;
- a proactive attitude towards problem resolution; excellent networking and client-orientation skills;
- eye for detail and good analytical capacities;
- strong sense of responsibility as well as the capacity to work autonomously, whilst at the same time being a good team player;
- very good knowledge of English and French, written and spoken are an advantage.
- Experience with the use of IT tools for grants management in the Commission is an asset.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG III. General** information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of one year**. Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents.

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.



The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
