STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission often recruits non-permanent staff. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit F.4 aims to support Finland, Sweden, Denmark, Poland, Czechia, Slovakia, Lithuania, Estonia and Latvia in the implementation of policies and funding linked to border, migration and security policies. The unit provides country specific policy /operational knowledge and analysis, coordinates with actors and stakeholders, such as EU agencies and international organisations on the ground, and manages the Home Affairs Funds for those countries for the current and next MFF.

WE PROPOSE

Unit F.4 is proposing a challenging Policy Assistant position in charge of migration, borders and security policy areas for the Member States under the responsibility of the unit. Under the supervision of the Head of Unit, the position includes gathering, analysing and disseminating country intelligence, monitoring policy developments, establishing and maintaining good relations with key stakeholders, preparing briefings and managing 2014 -20 and 2021-27 AMIF, BMVI and ISF programmes, in close cooperation with the Member States' Authorities.

You will be in regular contact with the Managing Authority(ies), ensuring appropriate monitoring of the performance of the programme, but also to support them in its implementation. This will include supporting negotiations and processing of amendments, processing payment requests, etc.

As main contact point for the Member State(s) and policy area(s) assigned to you, you will also support the preparations of briefings, European Parliament questions, access to documents requests, monitoring of fundamental rights developments, etc..



WE LOOK FOR

We are looking for an enthusiastic and motivated colleague with good planning, analytical and communication skills, with sense of responsibility and the ability to prioritise tasks. An ideal candidate should be forward-looking and dynamic, eager to develop and have the ability to work autonomously.

The job holder should be a flexible team player, able to work in close partnership with their colleagues. The post calls for good organisational and coordination skills.

Having previous experience in working with DG HOME main counterparts, most notably Home Affairs Funds Managing Authorities, and being familiar with key IT tools (SFC, RDIS, MyWorkPlace) would be a strong advantage. Experience with programme or project management, preferably in shared management, as well as analysis of financial and budgetary data, would be an advantage.

Candidates should have a very good command of English. Knowledge of official languages of the Member States covered by the Unit would be a definitive advantage.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first **contract will be of 1 years**. Subject to the interest of the service, the contract can be extended to a maximum duration of 6 years.

The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.
