STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Within the Common Implementation Centre (Directorate RTD.H) in DG Research & Innovation (DG RTD), the Common Audit Service (unit RTD.H2 - CAS) is a large multidisciplinary team that contributes to the legality and regularity of Research & Innovation expenditure by means of ex-post financial audits carried out either by its own auditors or by External Audit Firms (EAF). The main tasks of the CAS include: the implementation of the Horizon 2020 and Horizon Europe Audit Strategies; the implementation of the Euratom Audit Strategy; the performance of the complete audit cycle from planning, selection, execution to closure; the supervision of audits performed by the EAF; the coordination on sensitive/contentious audit cases; the recommendation of financial adjustments and, in case of systemic errors, the extension of the audit findings to non-audited transactions. Last but not least, the Unit manages the relations with the European Anti-Fraud Office (OLAF) for fraud prevention and detection, coordinates the implementation of the Common Anti-Fraud Strategy in the R&I family and is the European Public Prosecutor Office (EPPO) correspondent for the DG.

WE PROPOSE

Unit RTD.H2 is seeking to hire an interesting position as an Anti-Fraud correspondent with the following main tasks:

- Contribute to the definition and implementation of the R&I Common Anti-Fraud Strategy
- Coordinate the implementation of the Action Plan of the R&I family Anti-Fraud Strategy (RAFS), and the Commission Anti-Fraud Strategy (CAFS)
- Provide policy advice on fraud prevention and detection in R&I
- Prepare documents, reports, analyses as well as trainings, briefings, and presentations
- Contribute to fraud risk analysis, fraud risk assessments, policy advice, development and implementation on fraud prevention and detection in R&I
- Prepare files, reports and briefings for the hierarchy on fraud-related matters



- Contribute to communication activities on fraud prevention and for anti-fraud awareness raising
- Act as back-up to the OLAF and EPPO correspondent, for the coordination of the relations between DG Research and Innovation, OLAF and the EPPO
- Ensure the Secretariat of the Fraud and Irregularities in Research (FAIR) Committee

WE LOOK FOR

We are looking for a pro-active colleague with experience in audit, control, anti-fraud policy and/or risk management. Specific knowledge in anti-fraud policy is a particular asset. Well-developed analytical, organisational, problem-solving and drafting skills as well as motivation, initiative and flexibility are necessary. The candidate must be used to work both individually and as part of a team. A very good command of English (oral and written) is required as well as preferably also a good knowledge of French. Any additional EU language will be considered as an asset. Additional knowledge of EU Programmes and experience with the financial, legal and regulatory aspects of EU funded grants will be considered as an asset.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.
