STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit RTD.C.1 supports the development and implementation of the Clean Planet Directorate strategy towards an integrated, sustainable and climate neutral European energy, transport and urban sector. The unit's aim is to accelerate the scaling up and deployment of innovative Clean Planet solutions and maximize synergies between Horizon Europe activities, as well as between Horizon Europe and other EU and national funding and financing programmes.

The unit coordinates the contributions of the Clean Planet Directorate to the Horizon Europe Strategic planning as well as the development and implementation of cluster 5 activities. It is also responsible for the implementation of the Horizon Europe Mission on Climate Neutral and Smart Cities.

The unit builds bridges across DG RTD, interacting closely with other policy DGs and ensures an open and constant dialogue with the Member States, the research community, industrial stakeholders and relevant international partners for maximising synergies and impact of EU research and innovation.

The unit coordinates the communication and international cooperation activities for the Clean Planet Directorate including Mission Innovation.

WE PROPOSE

A dynamic and challenging position as a Policy Officer, contributing to the development of Research & Innovation policies in the area of Urban Transition with a specific focus on urban development and climate-neutral cities. The Policy Officer will contribute to the Climate Neutral and Smart Cities Mission secretariat and help develop in particular the activities supporting the implementation of



the Mission including through the Horizon Europe work programmes and the policies and initiatives of the Directorate General and of the Commission.

The Policy Officer will coordinate the cooperation with the NetZeroCities consortium, composed of 34 members and managing the Cities Mission Platform. The Policy Officer will also have close and regular collaboration/co-creation across Commission services including the Directorate-General for Regional and Urban Policy (DG REGIO) for the EU policy agenda for Cities and the Directorate-General for Energy (DG ENER) for the Affordable Housing initiative, the European institutions such as the Committee of the Regions and the European Parliament as well as regional and cities networks.

The Policy Officer will also be in close contact with the Executive Agencies managing the portfolio of projects of the Cities Mission, mainly the European Climate, Infrastructure and Environment Executive Agency (CINEA) including the flagship project of the Cities Mission Platform.

WE LOOK FOR

A highly motivated, dynamic and innovative colleague with a service-orientated approach. The candidate must have:

- good capacity for planning and organisation;
- the ability to provide quick input, strategic intelligence and analysis;
- the ability to prepare targeted policy briefings for the hierarchy, as well as swift and sound responses to stakeholder concerns or political issues.

A background, or qualifications, in the field of urban development or other related fields would be a very strong asset. Experience in EU policy processes and the Commission's internal procedures as well as practical experience on one or more aspects of the Framework Programme for Research and Innovation would be an advantage.

Excellent oral and written skills in English are required, allowing for effective communication with all counterparts and partners, as well as the capacity to establish solid collaborative working relations are essential. Any other language would be an asset.

Finally, the candidate should be a natural team player as s/he will be part of the Cities Mission team but also be capable of working independently.



HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from [the EPSO database](#)⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.
