STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Interpretation (DG SCIC) is the European Commission's interpreting service and domain leader for meeting room management and conference organisation.

Unit SCIC.C4 is responsible for meeting support and customer services at the Commission. This includes:

- Management of the corporate meeting spaces and of requests for meeting services, including requests for interpretation and technical services.
- First level technical support through the service 'My Meeting and Conference Support' (MACS) and management of the incidents (help desk, remote and/or on-site support).
- Front office services to meetings organized in the Commission's conference premises in Brussels and Luxembourg.
- Proximity services for audio-visual equipment in corporate and local meeting rooms, including the preparation for the meeting, the operator assistance when necessary and sound quality tests for hybrid meetings with interpretation.
- Management of the corporate tools for room booking (MIRA and WebDOR).

The unit consolidates and extends the use of the corporate platform for hybrid meetings with interpretation and it manages the Commission streaming service.

WE PROPOSE

Unit C4 of DG SCIC is seeking to hire a Project Assistant for a meeting and podcast studio. Her/his core role will be to coordinate the successful implementation of audio-visual projects in a future corporate studio in the Berlaymont building.

The jobholder will:

- Act as the key liaison between clients requesting use of the studio and the technical production team



- Analyse, clarify, and finalise studio usage requests in collaboration with all relevant stakeholders
- Monitor and follow up on studio requests, ensuring timely and successful project delivery
- Work closely with the production team to prepare and deliver high-quality audiovisual outputs
- Conduct post-event evaluations and address issues to support continuous improvement of future projects

This role is part of a new initiative with significant potential, offering the jobholder a valuable opportunity to contribute to and shape the communication activities of Commission services.

The working environment is demanding but also warm, supportive and friendly. Flexible working arrangements are used to ensure the best combination of personal and professional needs for all staff.

WE LOOK FOR

We are seeking an enthusiastic and highly motivated Project Assistant with a strong interest in operations and client services within an audio-visual studio environment. The ideal candidate should:

- Demonstrate a strong service-oriented mindset, with the ability to advise clients and deliver tailored solutions for studio use
- Possess excellent organizational and communication skills, both written and verbal
- Be comfortable operating in a complex, fast-paced environment with high expectations and demanding clients
- Show the ability to coordinate and implement projects effectively
- Bring a positive, proactive “can-do” attitude, along with strong interpersonal and relationship-building skills.

A background in audio-visual services and tools—particularly in multimedia and post-production—will be considered a strong advantage.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
