## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### WE ARE

Eurostat, one of the Directorates-General of the European Commission, is the statistical office of the European Union. Eurostat’s mission is to provide high quality statistics and data on Europe. Eurostat co-ordinates statistical activities at Union level and more particularly inside the Commission.

Unit E.2 is in charge of environmental statistics and accounts, and sustainable development. The mission of unit E.2 is to:

- provide environmental accounts in line with international standards and closely linked to the methodology of national accounts in order to facilitate analysis of the interaction between the economy and the environment;
- provide environmental statistics in the areas of waste, water, forestry and biodiversity indicators;
- maintain and update sustainable development indicators and indicators to monitor the circular economy;
- advance methodological work in the fields listed above.

The unit has 31 staff members organised in 4 teams and manages a budget of around €4 million per year.

The team monetary environmental accounts and forestry statistics has 6 members. The team’s main role is to run data collections of monetary environmental accounts based on Regulation (EU) 691/2011 or related voluntary collections, run one data collection of forestry statistics, assist Member States and develop methodologies.

#### WE PROPOSE

---

Unit E.2 of DG ESTAT is seeking to hire one statistical officer.

We propose a position for statistical officer in the team monetary environmental accounts and



forestry statistics. The job comprises an interesting mix of methodological development and data production. The jobholder will be in charge of the data collection on environmental protection expenditure account (EPEA). The job comprises the following main responsibilities:

- Collect, validate and publish data received from Member States, including calculation of EU aggregates;
- Assist the Member States in their reporting;
- Contribute to methodological work and developing Eurostat and UN guidelines to further enhance the comparability of the data;
- Contribute to the other activities in the team, including backing up colleagues;
- Represent Eurostat in international meetings.

## **WE LOOK FOR**

---

We are looking for a statistician specialised in environmental-economic accounts.

The ideal profile for the job should have the following qualifications and/or skills:

- Experience with monetary environmental-economic accounts (methodology SEEA), ideally with environmental expenditures, or environmental investments, for at least 5 years;
- Experience with national accounts (methodology ESA), for at least 5 years;
- Experience contributing to the international development of the SEEA Central Framework e.g. in fora such as the London Group of experts on Environmental-Economic Accounting or the technical sub-groups of the UN Committee of Experts on Environmental-Economic Accounting;
- Being comfortable using and/or easily adapting to use modern IT data production tools (knowledge of database management, MDT, VBA and/or R is an advantage);
- Experience presenting data in graphs and tables;
- Sense of initiative and being pro-active;
- Ability to work both autonomously and as part of a team.

Good command of English is a must. Knowledge of French would be an advantage. Previous knowledge of or experience in economic or environment statistics (i.e. different from the environmental-economic accounts) would be an asset but it is not a requirement.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

##### Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### **➤ Type of contract and working conditions**

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AD.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1<sup>st</sup> contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
