STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The International Relations Unit (Unit A5) is responsible for the "external (non-EU) dimension" of EU competition policy, and more in particular for DG COMP's relations with international organisations (e.g. ICN, OECD, WTO) and with third countries. We deal with enlargement countries (e.g. Albania, Serbia, Turkey), neighborhood countries (e.g. Ukraine, Moldova, Morocco, Tunisia) and have close contacts with the large competition authorities around the world (e.g. US, China, Japan).

WE PROPOSE

A position as Administrative Assistant to provide secretarial and logistic assistance to the case teams and horizontal working groups and in particular to the Head of Unit by maintaining the diary, filtering calls and taking messages, responding to general inquiries and managing the e-mail exchange and Outlook calendar. Ensure that procedures are applied in a correct, efficient and timely manner. The job involves teaming up with the other Assistants in the unit to coordinate secretarial work, to ensure the smooth functioning of the unit.

The work is varied, interesting and rewarding. The tasks will include consolidating and distributing the unit's work schedule and ensuring the appointment, documentation and follow up the unit internal meetings, as well as preparing notes, minutes, routine correspondence and presentations. It may also involve managing absence of unit members and similar personnel administration formalities and providing any other general administrative and logistic support in the performance of the unit's activities, as well as making travel arrangements for each member of the unit, including preparation of mission orders, files, hotel and travel bookings and expense claims.

The new colleague would have as an essential part of the job the monitoring of deadlines and workflow (agenda for the weekly meetings with the Commissioner, unit work programme ...) in close cooperation with the management, and ensuring that incoming inter-service consultation



requests, parliamentary questions, Cabinet requests, briefing and speeches requests are distributed to colleagues within the unit and that replies are introduced in time.

The unit has a friendly and stimulating working atmosphere with management and colleagues who pay attention to human relationships. Officials are given a high degree of autonomy and debate, and exchange of opinions is encouraged. We apply normal working hours/flexibility and have a family friendly environment.

WE LOOK FOR

A motivated and dynamic colleague, who will share the tasks of the unit's secretariat with another colleague. The post requires reliability, accuracy, service culture, strong inter-personal skills and excellent organisational skills. The candidate should demonstrate a sense of initiative and ownership, pragmatism as well as willingness to assume responsibilities. The ability to work both as a member of a team and independently are key for the job.

He/she should have good knowledge of the standard IT tools (Word, Excel, PowerPoint, Outlook, etc.) and a very good command of English. A good command of other languages, in particular “world languages”, as well as familiarity with Commission procedures and the working methods of DG Competition would be an advantage. We encourage as well the conscient use of Artificial Intelligence at work.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
