STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit ENER.F.3 “International Relations” is part of the Directorate for Energy Security and International Relations within the Directorate-General for Energy (DG ENER). The Unit contributes to the development and implementation of the EU’s external energy policy at an important stage for Europe’s energy security and clean energy transition.

ENER.F.3 coordinates DG ENER’s international energy engagement, supporting partnerships with third countries and contributing to the implementation of the External Energy Engagement Strategy under REPowerEU and the European Green Deal. Its work helps advance efforts to diversify energy supplies, strengthen energy resilience, and support the EU’s external energy objectives, including outreach related to reliable and competitive energy imports.

Within DG ENER, which is responsible for developing and implementing EU energy policy, the Unit contributes to ensuring that the external dimension is aligned with broader objectives such as secure, affordable, and clean energy, as well as the transition towards climate neutrality by 2050.

The Directorate for Energy Security and International Relations coordinates actions aimed at reinforcing the EU’s energy resilience and external partnerships. In this context, ENER.F.3 works closely with the European External Action Service, EU Delegations, and other Commission services.

The Unit brings together around 20 colleagues working in a collaborative and international environment.

WE PROPOSE

Unit F.3 of DG ENER is seeking to hire one International Relations for Energy Team Leader.

The position will consist of leading the team on “Emerging Economies and Just Transition” and steering the development, coordination, and implementation of the EU’s energy relations with key Global South partners, including South and South East Asia, Latin America and the Caribbean, and



Sub-Saharan Africa. The portfolio covers clean technologies, critical raw materials, just transition and international partnerships, and carries significant managerial and strategic responsibility in a dynamic working environment.

WE LOOK FOR

We are looking for a proactive, committed and result-oriented colleague. The ideal candidate should possess the following competencies:

- Relevant job experience of at least 10 years of proven full time professional experience in international cooperation including European foreign policy, international trade and investment, and development cooperation including representation and negotiation with national and local governments.
- Experience working with Global South regions including Latin America, South and Southeast Asia and Africa, notably emerging economies such as India, Brazil, South Africa.
- Experience of working in multicultural environments, notably in partner countries including experience in Member States' diplomatic missions/EU Delegation and third sector.
- Knowledge and experience in the management of EU's financial instruments for external action.
- Strong analytical skills, and the ability to link analysis and policy development, and well-developed political judgement.
- Good oral and written communication skills.
- High personal commitment on quality and accuracy, and ability to deliver within short deadlines.
- Capacity to perform duties autonomously and in a flexible way is important, coupled with strong team spirit.
- An excellent command of English is essential. Knowledge of French and Spanish is an advantage.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

FOR AD jobs: In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

FOR AST and AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English/French and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission. Candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d)/2(a) of the [Conditions of Employment of Other Servants](#), in function groups AD, AST or AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
