## STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

The Directorate for Financial Markets' Policy (FISMA C) develops and implements policies to ensure integrated, efficient and stable financial markets across the European Union. Working closely with key stakeholders, including the European Securities and Markets Authority (ESMA), the Directorate strives to uphold the highest standards of market integrity, investor protection and transparency in trading and post-trading activities. A core part of its mission is to facilitate a single market for asset management within the EU, fostering cross-border opportunities while enhancing competitiveness and investor confidence. Additionally, FISMA C focuses on improving the quality and accessibility of corporate information, including financial and non-financial reporting, to ensure that markets operate on a foundation of reliable and comparable data. Through its regulatory and policy work, in collaboration with ESMA and other EU institutions, FISMA C contributes to a resilient, transparent and well-functioning financial system that supports sustainable growth and serves the needs of businesses, investors and citizens alike.

### WE PROPOSE

We are offering an opportunity to work in a stimulating and highly rewarding work environment, which has high exposure to senior management and to the Cabinet and the Commissioner. The selected candidate will provide administrative and organisational support to the Director, including agenda and mission management, and help with various administrative and coordination activities, such as briefing attribution, planning and managing the Directorate's human and financial resources, ensuring the circulation of documents, as well as document management. The successful candidate will work closely with other administrative staff in the Directorate. The post will involve contacts with other services of DG FISMA and the Commission, as well as with the Cabinet of the Commissioner and external actors.



## **WE LOOK FOR**

A proactive and highly organised professional assistant/secretary with excellent drafting skills (minutes, reports, briefings) and a keen eye for detail. The successful candidate will manage a diverse range of administrative and secretarial tasks, while liaising effectively with EU agencies such as ESMA and the ESAs.

You should have practical knowledge of the Commission's budgetary rules and administrative procedures, along with proficiency in standard Commission tools (Ares, Basis, MIPS, Sysper, Decide) and advanced MS Office skills.

Fluency in English and French (C1 level) is essential, with the ability to draft clear, accurate documents and take precise minutes in multilingual settings. A discreet, diplomatic, and team-oriented approach is crucial, as the role involves handling confidential matters and collaborating with colleagues and external stakeholders.

The ideal candidate will be adaptable, service-minded, and capable of working independently in a fast-paced environment.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

#### Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

### ➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority<sup>3</sup>. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

## ➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1<sup>st</sup> contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
