STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of Directorate A is to lead on the EU's enlargement policy and strategy, ensuring its consistent application across all candidate countries and potential candidates, and leading on the fundamentals. The Directorate provides strategic steer to policy development, priority-setting, development of the new financing instruments (MFF), and the programming of EU financial assistance to the ENEST regions, while ensuring the DG's monitoring and internal learning functions. The Directorate spearheads ENEST's private sector engagement and mobilisation of investments, and maximises the use of EU financing, financial and institution-building instruments (TAIEX, Twinning) in support of the DG's political and policy priorities.

WE PROPOSE

A position as Policy Assistant to the Director of Directorate A (Enlargement Coordination, Strategy and Investments) covering a wide range of coordination and management tasks in a dynamic and varied working environment. The selected candidate will provide direct support to the Director across the full range of Directorate A's activities. The post combines high-level policy and Directorate coordination with hands-on involvement in enlargement policy, HR management, budget execution, audit and contract matters, communication and offers direct exposure to the DG's senior management.

She/he will in particular:

- Provide advice and input on specific files, policy development and the definition of strategic objectives, especially on politically important issues (enlargement, institution building, private sector engagement and investments with IFIs, MFF budget, reporting).
- Contribute to the drafting and regular monitoring of the strategic objectives of the Directorate.
- Monitor and follow up on Directorate A's administrative and operational budget execution,



ensuring compliance with the Financial Regulation and internal procedures.

- Contribute to the coordination of internal control activities, including follow-up of internal control recommendations in collaboration with Directorate R.
- Assist Units in HR management processes such as recruitment, mobility, renewals and training.
- Draw on expertise in the EU external relations and enlargement policy to support geographic Directorates within DG ENEST in policy coordination tasks as required.
- Contribute to the preparation of briefings and other communication products for the Director, leveraging experience in political drafting and institutional communication, coordinating with geographical Directorates or Resources Directorate where relevant.
- Lead on a communication strategy and communication elements for the activities of the Directorate.

WE LOOK FOR

A proactive, well-organised and analytically minded professional with solid experience in the EU institutional settings, as well as EU external policies and enlargement in particular, ideally gained within the European Commission.

She/he should demonstrate experience in cooperation with third countries and EU external assistance programmes as well as experience with EU financial assistance and project management, including design, formulation, management and monitoring of projects (preferably with a focus on enlargement and/or neighbourhood policies).

The ideal candidate should be able to work autonomously and as part of a larger team, manage multiple priorities under pressure. She/he would be required to ensure the coordination and quality assurance of documents proving excellent drafting and communication skills in both English and French with accuracy and rigour.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and French.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AD.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
