STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

We are the Innovation & Strategic Autonomy Unit in DG HOME. Our mission is to strengthen the Union's strategic autonomy in the area of science, innovation and technologies supporting an area of freedom, security and justice without internal frontiers. To this end, the Unit manages and implements Horizon Europe and the future European Competitiveness Fund for all security matters and is responsible for all relevant security appraisals and screenings.

WE PROPOSE

We propose a position in a friendly and stimulating work environment in the field of innovation and strategic autonomy. The chosen candidate will be working in a larger team responsible for security matters and support the wider unit managing information flows and analytical inputs related to the internal security assessment of policy initiatives, projects and investments, as well as the implementation of the financial framework, ensuring that the team has timely access to the knowledge required to perform its tasks.

He/she will also act as EU Classified Information (EUCI) Deputy Registry Control Officer (RCO) and point of contact, in the context of the DG HOME EU Classified Information Registry, supporting the main DG HOME Registry Control Officer. He/she will support the coordination and implementation of the preparation, registration, reproduction, dispatch, archiving and destruction of EU classified information, in accordance with document management and security provisions.

He/she will also assist with the implementation of the European Competitiveness Fund and Horizon Europe, including through the development and implementation of work programmes and the management of the programme committee and specialised stakeholder groups. He/she will support the activities and further development of the expert communities and strategic events, including the Community for European Research and Innovation for Security (CERIS) and security technology events, in close cooperation with the other colleagues of the Unit and beyond.



WE LOOK FOR

We would very much welcome a colleague with very good analytical skills and excellent drafting skills. In addition, he/she should be well organised, able to observe the deadlines and comply with administrative procedures. He/she should combine good team spirit with a sense of initiative and be able to work independently. The candidate should have or be willing to swiftly request the security clearance to the responsible authority. The ideal candidate would have knowledge of the EU classified information rules.

Mastering English, both spoken and written is a requirement. We believe in lifelong learning and continuous development and the selected candidate will have easy access to training in order to further enhance his/her skills and knowledge.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission. Candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(d) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
