## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

Unit MOVE.B2 (Transport Investment) in the Directorate-General for Mobility and Transport (DG MOVE) is responsible for shaping and implementing EU investment policy in the transport sector. We are a team of about 20 dynamic and highly motivated professionals who enjoy working both independently and collaboratively. Our unit steers investments in sustainable, smart, and resilient transport infrastructure through a variety of EU funding programmes, notably the Connecting Europe Facility (CEF), the Social Climate Fund and InvestEU. We ensure strategic alignment between EU transport funding and key policy priorities such as the European Green Deal, the Trans-European Transport Network (TEN-T), digitalisation, and military mobility. We work closely with the European Climate, Infrastructure and Environment Executive Agency (CINEA), financial institutions (including the European Investment Bank), Member States, and other Commission departments. ### WE PROPOSE

---

Unit B.2 Transport investment of DG MOVE is seeking to hire a contract agent supporting the implementation of the Social Climate Fund.

The job involves participating in the processes for the design, negotiation, and execution of national social climate plans, with regard to addressing transport poverty in the EU. It requires close cooperation with Member States and the relevant Commission services, such as DG EMPL and DG CLIMA, to ensure effective Fund deployment. The responsibilities include providing analyses of transport poverty situation in Member States and assessing their transport-related investment needs, assessing costing estimates of transport related measures and investments proposed in the national plans, engaging with national authorities, and providing technical guidance for plans preparation, assessment and implementation. The position also entails monitoring progress, checking the delivery by Member States of milestones and targets under their national plans as well as contributing to the European Semester policy development and ensuring coordination with other Commission services in the area of transport investments. The jobholder will work in a small



team of colleagues dealing with the Social Climate Fund in DG MOVE.

While the Social Climate Fund will be the core responsibility, the job may include also other tasks related to preparations for the next Multiannual Financial Framework and transport investments in general.

## **WE LOOK FOR**

We are looking for a motivated candidate experienced in:

- transport policy analysis and monitoring
- EU policy coordination
- negotiation and handling conflicting views

The job holder will also be expected to demonstrate:

- initiative, team spirit, and the ability to prioritise effectively
- ability to work methodically and with attention to detail
- pro-active attitude towards problem resolution, excellent networking skills
- capacity to conceptualise problems, identify and implement solutions
- capacity to organise tasks efficiently and to deliver in a structured way
- strong sense of responsibility as well as capacity to work autonomously
- capacity to work in a team
- excellent drafting skills in English, and ability to synthesise complex technical issues.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

The selecting unit chooses from [the EPSO database](#)<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in **English** and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### ➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
