STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit DGT.A.1.IT.1, based in Brussels, is one of the two Units of the Italian Language Community of the European Commission's Directorate-General for Translation (DGT).

DGT is one of the world's largest public translation services and the domain leader for all translation-related work in the European Commission. Its work focuses on 3 main pillars: providing high-quality translations, offering editing services to help produce clear texts, and delivering AI-based multilingual services like eTranslation. DGT also promotes multilingualism and supports language professions. These efforts help the EU communicate effectively with its citizens and contribute to democracy and competitiveness.

DGT.A.1.IT.1 provides the translation into Italian (mostly from English) of documents in the following policy areas: agriculture, economic and financial topics, including the European Semester, climate, energy and the environment, competition, home affairs and migration, external relations, justice, research and taxation.

We primarily translate legislative proposals, as well as policy documents, press releases, web texts and material for the public on a very wide spectrum of domains of relevance to the life of EU citizens.

Currently the unit consists of the head of unit, 25 translators and 6 assistants.

WE PROPOSE

DGT.A.1.IT.1 is seeking to hire one linguistic agent who will work closely with the Head of Unit, colleagues from the secretariat team, a team of translators, and other colleagues within the Italian Language Community and other DGT services.

The position will consist of diverse and challenging linguistic and administrative tasks, including:

- Management of the unit's daily workflow of incoming and outgoing documents (i.e. originals and translations, including versions)
- Checking and finalising translations; text formatting
- Handling outsourcing of translation work
- IT-based translation processing tasks (pre- and post-processing)
- Support to translators and the head of unit



- Collaborative platform management
- Standard secretarial and administrative functions within the unit secretariat using MS Outlook, M365, and internal DGT software

WE LOOK FOR

We are looking for a candidate with:

- * Excellent command of Italian (native-level proficiency)
- * Very good knowledge of Office suite
- * Strong IT and communication skills
- * A service-oriented, proactive, and dynamic approach
- * The ability to work both independently and collaboratively within a team.

The ideal profile for the job is someone with strong IT skills and excellent command of English. The knowledge of French would be an asset as well as familiarity with computer-assisted translation tools. Flexibility and adaptability are essential, as the candidate must be prepared to navigate a rapidly evolving environment, including changes in IT systems, AI integration, and organisational structures.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and Italian.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AST/SC.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
