STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General of Agriculture and Rural development (DG AGRI) is the department of the European Commission, responsible for shaping the EU's agricultural policies.

The External Communication & Promotion Policy unit is composed of 37 people of different nationalities and has the responsibility to manage DG AGRI's external communication strategy with a view to getting across the messages about the Common Agricultural Policy and its economic, environmental and social objectives, to the general public, stakeholders and media. Our activities include a broad range of communication and information actions (fairs, conferences, events, electronic publications, website, social media, multichannel campaigns, creation of audiovisual material, press relations and grants to information multipliers towards the general public and the agricultural world).

WE PROPOSE

The External Communication and Promotion Policy Unit (F1) in DG AGRI is seeking to hire one senior communication officer to manage a brand-new innovative multichannel EU-wide campaign about the quality of European food intended for citizens and to be deployed in 27 Member states. The campaign will be highly visible and attract attention from European institutions, national authorities and agriculture and food stakeholders.

Your role will include

- Revise campaign strategy, visuals and visual identity, messages and creative concept, audience testing, prepare media plans, and validate assets prepared for the campaign.
- Develop and implement strategies for communication materials (publications, audiovisual content) to amplify the campaign's reach and effectiveness.
- Ensure synergies and coherence between the campaign and DG AGRI external communication actions.



- Lead and oversee programme/project management, from preparation and logistical planning to monitoring progress; present DG/Commission/EU policies to diverse stakeholders—public, civil society, private/public organisations, and governmental representatives—through outreach activities, conferences, and public events.
- Contribute to the development of DG AGRI's external communication strategy and annual action plans.

The atmosphere in the unit is relaxed and cooperative, very dynamic and focused on high-quality work in the best interest of the Commission.

WE LOOK FOR

We are looking for a communication expert with experience of at least 10 years in multi-media communication, including in the management of integrated multichannel campaigns across Europe (digital, media buying, events, etc.). Experience in communicating about European food and agriculture and awareness of sensitivities around agricultural and trade policy are also required.

The ideal profile for the job is an experienced communicator with an academic degree in communication and/or relevant experience in communication and more precisely in managing integrated multichannel campaigns (media relations, social media, digital marketing and paid media, events organisation).

S/he should have good oral communication skills and be comfortable delivering frequent presentations to stakeholders and national administrations on the content and state of play of the campaign. S/he should have a dynamic personality, a constructive attitude and a high sense of responsibility.

Cultural awareness for adapting messages to diverse European audiences and ability to work with local communication teams and agencies are also an asset.

An excellent command of English is required. A good knowledge of French and other languages would be an advantage.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from [the EPSO database](#)⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be one-year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
