### **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **temporary agents** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **contract agents** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

#### WE ARE

---

The Joint Audit Directorate for Cohesion (Direction d'audit de la Cohésion - DAC) provides assurance and audit results to both Directors-General - of DG EMPL and DG REGIO - for all funds under Cohesion policy as well as indirect and direct management. The DAC is entrusted to test the effectiveness of management and control systems, ensure the respect of applicable rules for all programmes. These are key factors that will contribute to the success and good reputation of the Funds.

The successful candidate will be part of the DAC Directorate, while remaining on a functional post in EMPL. The DAC unit (DAC4), to which the successful candidate chosen will be assigned, is notably in charge of auditing the Cohesion policy funds [European Regional Development Fund (ERDF), Cohesion Fund (CF), European Social Fund (ESF), Fund for European Aid to the Most Deprived (FEAD)] in the Member States Spain, Portugal, Greece, Cyprus and Bulgaria.

#### WE PROPOSE

---

We propose a post of external auditor for Spain and Portugal. The work consists of:

- a) ensuring that required management and control systems for the implementation of the cohesion policy programs in Spain and Portugal are set up and functioning correctly (through desk review, remote and on-the-spot missions);
- b) assessing the work of the audit authority, including annual control reports, annual accounts and national audit reports,
- c) support the geographical desks in both DG REGIO and DG EMPL in charge of Spain and Portugal with the relevant audit expertise, assist other auditor(s); and
- d) accompany other auditors in Member States he/she is not principally in charge of.

The successful candidate will be required to carry out 3-4 audit missions per year.



## **WE LOOK FOR**

---

We are looking for highly motivated, results-oriented and proactive candidates with an audit experience, or experience in legal analysis, programme / project management, implementation of EU or sector-specific policies.

Candidates should have confirmed strong analytical skills and a solid understanding of EU funding instruments, preferably through work experience linked with auditing EU funds or practical implementation of the relevant policy areas.

The future colleagues are expected to have good analytical and organisation skills, a good sense of initiative and responsibility as well as good communication skills. They must be good team players, be able to quickly identify key issues and deliver quality outputs.

Competency in the languages relevant for carrying out audit missions in the unit: Spanish and Portuguese are an asset. Very good drafting skills in English are a big advantage.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

##### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

##### Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

##### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>2</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>3</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)<sup>4</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### **➤ Type of contract and working conditions**

The place of employment will be in **Brussels**

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

[For 3b] The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.
