STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

We are the International Unit of the Directorate-General for Employment, Social Affairs and Inclusion (DG EMPL), part of the Directorate responsible for Labour Mobility and International Affairs.

The mission of Unit E.3 is to promote the decent work agenda in the EU external relations, including in the context of the enlargement process, building upon the European Pillar of Social Rights and the EU employment and social acquis. In particular, the Unit's work includes the following main strands:

- Support the enlargement countries in their path towards EU membership in relation to employment and social policies, in terms of both legislative alignment with the EU acquis and capacity building of labour market institutions and social partners;
- Ensure that international labour standards are mainstreamed across EU trade policy, particularly in the context of Free Trade Agreements and GSP+/EBA preferential arrangements.
- Promote decent work and ensure EU representation on labour issues in the context of multilateral organisations (e.g. ILO and other UN bodies, OECD, Council of Europe) and fora (G7, G20);
- Promote and support labour dialogues and cooperation with neighbouring and other partner countries at regional (e.g. in the context of the Union for the Mediterranean) or bilateral level (e.g. with Japan, Canada, US).

The Unit also follows up the level playing field dimension in the Trade and Cooperation Agreement with the United Kingdom, and coordinates as well relations with EEA, EFTA countries in the employment and social area.

Finally, Unit E.3 is also responsible for managing the relations with the European Training Foundation, a decentralised agency working on human capital development in enlargement and neighbouring countries.

WE PROPOSE

We propose a position of Administrative Agent to support and contribute to the work in Unit E.3 across the various teams. The successful candidate will be responsible for various administrative and secretarial tasks, such as:

- management of documents and correspondence;
- keeping track of deadlines for the tasks assigned to the Unit to ensure timely delivery;
- ensuring the proper coordination, communication and timely preparation and validation of briefings;



- supporting the organisation of meetings and high-level events;
- assisting colleagues in preparing missions;
- providing support for human resources management.

The jobholder will act as the document management and IT correspondent for the Unit and will ensure the optimization of the Unit's collaborative spaces in Teams and SharePoint.

WE LOOK FOR

The ideal candidate should be an excellent team player with a good sense of initiative and responsibility. He/she should be reliable, proactive, thorough and well organised, and should assure quality and accuracy in performing a diversity of tasks without constant supervision. The successful candidate should be flexible and be willing to work atypical hours if required in the interest of the service.

A good knowledge of and proven experience with the administrative procedures of the Commission and its corporate IT tools (e.g. ARES, BASIS, MIPS, SYSPER2, DECIDE, Teams) is an advantage. Very good knowledge of English and French is an important advantage. Other languages would be an asset.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

2. You should send your documents in a single pdf in the following order:
 1. your CV
 2. completed application form.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG II**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.
