## **STAFF RECRUITED ON CONTRACTS**

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

### WE ARE

Unit JUST.B.4 deals with the product safety policy, aiming to ensure safety of non-food consumer products. Our objective is to help keep dangerous non-food products out of reach of consumers and out of the Single Market. We are responsible for the General Product Safety Regulation (GPSR), and the EU Safety Gate Rapid Alert System for dangerous non-food products.

Our work also includes coordinating and supporting market surveillance authorities in the Member States to ensure proper enforcement of EU product safety rules. Because buying habits constantly change, we also deal with the safety of products sold online and address new technology developments in the field of product safety. In addition, since the market is global, we work with stakeholders and authorities all over the world to cooperate and act to enhance product safety for consumers.

### WE PROPOSE

---

If you would like to contribute to product safety in the Single Market and for your work to have a direct impact on the daily life of all European citizens, we propose a challenging and rewarding job as an administrative agent in the area of consumer product safety.

The position will consist of providing administrative and technical support in relation to the operation of the Rapid Alert System for dangerous non-food products (Safety Gate) under the General Product Safety Regulation, as well as to document management, internal communication and meetings. Monitoring deadlines for policy files and administrative actions. The job holder will participate in the work of the Safety Gate team, as regards the validation process of notifications and reactions submitted by the Member States via the Safety Gate IT system; and contribute to the processing and follow-up of the notifications submitted by the Member States.



Moreover, he/she will provide complete administrative and logistic support for the organisation of Working Groups meetings using Commission's systems, as well as other internal and external events organised by the unit, such as meetings, workshops, conferences and public events.

In addition, the new colleague will contribute to the administrative support to the unit and the Head of Unit including management of the unit's functional mailboxes, handling documents and mails. Providing backup support to the unit assistant during absences or periods of high workload. Work may further include tasks on processes related to inter-service consultations, petitions, parliamentary questions, adoptions procedures, logistics.

## **WE LOOK FOR**

---

We are looking for a reliable, motivated and dynamic colleague, who will contribute to ensure that the unit and its secretariat run smoothly from an administrative point of view. The new colleague should be able to work in a proactive, autonomous and highly organised manner, be able to prioritise work and capable of working well as part of a team. The job requires good organisational and inter-personal skills and a sound knowledge of Commission IT management tools would be an asset. In case the candidate is not yet familiar with all those systems, he/she has to be ready to learn them quickly after joining the Unit.

The successful candidate should have a good knowledge of English. Knowledge of French and/or other EU languages is an asset.

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

In practice, to express your interest, please follow the subsequent two steps:

2. You should send your documents in a single pdf in the following order:
  1. your CV

## ANNEX

### 1. Selection

#### ➤ Am I eligible to apply?

#### **You must meet the following eligibility criteria when you validate your application:**

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

#### General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

#### Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

#### Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU<sup>1</sup>
- AND have a satisfactory knowledge (minimum level B2)<sup>2</sup> of a second official language of the EU, to the extent necessary for the performance of the duties.

#### ➤ What about the selection steps?

The selecting unit chooses from [the EPSO database](#)<sup>3</sup> candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

## **2. Recruitment**

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

### **➤ Type of contract and working conditions**

The place of employment will be in **Brussels**

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG II**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
