STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit ECFIN.C4 “National Fiscal Frameworks and Institutions” is responsible for improving the conduct of fiscal policies in the Member States (i.e., achieving sound budgetary positions, more efficient spending, stronger independent fiscal institutions, etc.) and supporting EU priorities such as the green transition through stronger national fiscal frameworks and institutions.

The unit is responsible for the National Budgetary Frameworks Directive, conducts analytical and policy-related work and contributes to economic and fiscal surveillance in EU Member States. Unit C4 also supports the implementation of the European Green Deal, in particular by mainstreaming environmental and climate change objectives into the Member States’ fiscal policies and fiscal governance arrangements, by promoting the use of ‘green budgeting’ and effective management of the fiscal impact of natural disasters. It promotes efficient public spending with its work on the quality of public finances, notably with regards to public investment management and spending reviews.

The unit serves as DG ECFIN’s contact point to Eurostat and competence centre for budgetary statistics, and it maintains a comprehensive Fiscal Governance Database. In its outreach activities, the unit organises annual conferences on national fiscal frameworks and green budgeting and meetings with independent fiscal institutions (IFIs). We work closely with our partners inside the Commission (Eurostat, REFORM, ENV, CLIMA, BUDG, ECHO, JRC) and outside (IFIs, World Bank, IMF, OECD, national authorities, Coalition of Finance Ministers for Climate Action).

WE PROPOSE

We are offering a position as secretary to the Head of Unit and the unit staff, in a friendly and inspiring work environment and a dynamic team of about 10 people. The successful candidate should ensure a smooth running of the secretariat and provide general administrative support to the Head of Unit and the members of the team. This includes secretarial and administrative tasks, like administrative coordination and support (managing online calls, diary-keeping, missions, absences, etc.), document management services and involvement in legislative processes. A key responsibility will be the organisation of unit events both internal and external. The position also includes producing and disseminating ECFIN Discussion Papers and other publications and



managing the unit's input to the ECFIN intranet. We offer an interesting working environment in a friendly team. As all secretaries in the directorate, the job holder can be asked to support other units, the director's office or undertake other tasks within the directorate where necessary.

WE LOOK FOR

This is an ideal post for a dynamic and well organised secretary with some years of relevant professional experience who is looking to develop in this role. S/he should be self-motivated and able to organise her/his work independently and show a strong sense of initiative and responsibility. Good planning and the ability to perform multiple tasks and adjust to changing priorities are essential. A positive attitude, good communication skills and excellent human relations are essential; a good knowledge of the administrative procedures of the Commission would be appreciated but is not requested. A high level of English, the main working language, is indispensable; a good working knowledge of French would be appreciated.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

FOR AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
