STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Directorate ECHO.E "Resources" delivers essential cross-cutting support to the European Civil Protection and Humanitarian Aid Operations (DG ECHO), ensuring that its operations run efficiently, compliantly, and securely. It comprises of 5 Units and the HR Correspondent team. The Directorate ensures that reporting mechanisms are robust and aligned with both internal and external requirements, facilitating transparency and accountability in all operations. It ensures that funds are used efficiently and in compliance with EU financial regulations and that they are supporting the overall objectives and priorities of the organisation. The directorate provides legal guidance, ensuring that DG ECHO's activities adhere to EU and international legal frameworks, protecting DG ECHO's operations from legal risks. The directorate is providing security management, ensuring the safety of staff, including in the field and in high-risk environments. The Directorate also facilitates the work of and manages DG ECHO's Field Network of humanitarian experts. The Directorate furthermore delivers technical and digital solutions to support DG ECHO's operations. Finally, the HR Correspondent Team ensures that HR policies and practices are effectively implemented, supporting staff well-being, recruitment, and professional development.

WE PROPOSE

We are looking for an experienced secretary to the Director. The successful candidate will be closely integrated in a friendly and dynamic team. She/he will provide administrative, logistic and secretarial support to the Director. She/he will be given a broad range of administrative responsibilities as well as a high degree of flexibility in the organisation of his/her work in accordance with the priorities of the Director. She/he is expected to attribute, follow up and file ARES documents and mail, apply the document management rules, launch briefing requests in Basis for the Director, monitor deadlines, ensure calendar planning and the organisation, preparation and follow-up of meetings. She/He will provide administrative and logistical support for the organisation of meetings and events. She/he will help to maintain an effective information flow and communication within the Directorate and towards other services and external contacts. In particular, she/he will prepare documents and notes, assist with Sysper and recruitments, ensure document filing, arrange videoconferences and organize missions in MIPS. She/he will work in close collaboration with other members of the director's team.



WE LOOK FOR

We look for a dynamic, flexible, proactive, service-oriented and open-minded team colleague. The successful candidate should have sound organisation skills, be flexible, being able to prioritise tasks, handle high workload and sensitive information with the necessary discretion. She/he must have a minimum of three years of related professional experience. Written and spoken fluency in English and a good knowledge of French is a requirement. Knowledge of Commission procedures and administrative rules, and experience in document management would be an asset. The successful candidate will need to be familiar with Commission IT tools: Ares, MIPS, SYSPER, Decide, Eurolook, Basis etc. Suitable candidates must be able to respond rapidly to changing circumstances and to communicate effectively. We welcome the motivation and capacity to induce improvements in the working environment and procedures. Sense of initiative and enthusiasm would be particularly appreciated. Previous experience as an executive secretary is an asset.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least either a level of post-secondary education attested by a diploma, or a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be in **Brussels**

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

➤ Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new competition published or already planned in the field. If there is none, recruitment will be at the level of AST/SC1. The maximum recruitment grade is AST/SC2, which may be granted based on the assessment of the needs of the service, notably the nature of the profile sought, the level of responsibility to be exercised, or the labour market conditions for the profile in question, and the duration of the candidates' previous appropriate professional experience.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
