STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of the Directorate-General for Justice and Consumers (DG JUST) is to vindicate and strengthen the rights of people living in the European Union, whether they are acting as citizens, as entrepreneurs, as consumers or as workers, wherever they are in the EU. Our policies are based on Europeans' core values and principles – freedom, democracy, rule of law, equality, tolerance, and respect for human rights.

In DG JUST, Unit D.1's mission is to manage EU policy on equality and non-discrimination for LGBTIQ+ people and older people and to coordinate horizontal matters related to equality and non-discrimination, including equality mainstreaming. In particular, the unit is responsible for:

- Developing and implementing EU policies and legislation to promote equality and combat discrimination, particularly on the grounds of being LGBTIQ+ and age, and across several discrimination grounds;
- Ensuring and monitoring the implementation of the LGBTIQ+ Equality Strategy 2026-2030;
- Developing and implementing EU policy to promote the collection and use of equality data;
- Enhancing diversity and inclusion at work (Diversity Charters, Diversity Month) and locally (European Capitals of Inclusion and Diversity Awards);
- Promoting and coordinating equality mainstreaming in EU policies, legislation and funding programmes as appropriate, and supporting the Commission's Task Force on Equality;
- Coordinating work on certain Member State expert groups, networks and horizontal tools relevant to equality;
- Implementing the Citizenship, Equality, Rights and Values (CERV) Programme strands linked to the unit's files.

WE PROPOSE

We offer an opportunity to work in dynamic and sensitive policy areas.

The position will consist of providing administrative and organisational support to the unit and the Head of Unit. The candidate will carry out a broad spectrum of secretarial tasks including the follow-up of internal procedures and deadlines, handling incoming correspondence, information and document management, organisation of meetings and providing for logistic needs, coordinating and monitoring requests and deadlines, preparing missions, assisting with the Human resources management of the Unit, supporting communication activities.

The successful candidate will work closely with all unit members, and with the secretariats of other units, given in particular the horizontal tasks of the unit. The post involves contacts with other services of DG JUST and the Commission as well as with external actors.

WE LOOK FOR

We are looking for an experienced, motivated and dynamic colleague, who will contribute to ensure that the unit and its secretariat run smoothly from an administrative point of view. The new colleague should be able to work in a proactive, autonomous and highly organised manner, be able to prioritise work and like to be part of a larger and pleasant team. The job requires good organisational and inter-personal skills and the ability to become quickly operational within the relevant Commission IT management tools. The ideal candidate will be adaptable, service-minded and capable of working independently in a fast-paced environment.

Very good oral and written communication skills in English are indispensable. Knowledge of French would be an asset. At least 2 years of relevant professional experience in operational and administrative support would be desirable.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language (French).

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
