STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General Maritime Affairs and Fisheries (DG MARE) is responsible for the development and implementation of the Integrated Maritime Policy and the development, implementation and monitoring of the Common Fisheries Policy. The DG has around 380 staff, distributed over 5 Directorates and 21 Units. The wide variety of responsibilities at the heart of the Commission's political priorities creates an interesting and challenging work environment.

The General Affairs and Resources Directorate provides support services to the entire Directorate-General by guiding the strategic planning of its activities, furthering relations with the other institutions and effective internal and external communication, ensuring compliance with the applicable EU and international law and optimising the allocation of available human and financial resources.

Unit MARE.E.4 is the internal legal service of DG MARE. It provides legal support and advice to relevant MARE units and hierarchy on the development and implementation of the Common Fisheries Policy and of the Integrated Maritime Policy, as well as in the international context. It also supports the Legal Service of the Commission in cases before the Court of Justice of the EU. The unit also co-ordinates all legal enforcement action (complaints, pilots and infringements), access to document requests, input to State aid files and data protection issues for DG MARE. The team is small, but highly motivated and friendly, and working conditions are very flexible.



WE PROPOSE

DG MARE proposes an interesting and challenging position for a dynamic official as legal officer and case handler in MARE.E.4.

The selected candidate will in particular perform the following tasks:

- provide legal advice to relevant MARE units and hierarchy on the internal dimension of the Common Fisheries Policy and Integrated Maritime Policy, as well as on the external dimension (e.g. International Ocean Governance, Trade and Cooperation Agreement with the UK, Sustainable Fisheries Partnership Agreements) - support policy units in the preparation and implementation of relevant legislation and implementing acts
- support the Legal Service of the Commission in cases before the CJEU
- handle complaints, Pilots and infringement cases
- co-ordinate and provide advice on access to document requests and State aid consultations
- deputise for the DG MARE Data Protection Co-ordinator.

WE LOOK FOR

A motivated and dynamic colleague with a legal background and a specialization in EU and/or international law, a strong analytic mind, capacity and appetite for strategic and political thinking, excellent communication and negotiation skills, a high sense of responsibility, team and service orientation, excellent planning and organizational skills and an open and friendly personality. Previous experience with legal advice, international negotiations, complaints, pilots and infringements, access to documents, State aid consultations and/or data protection is highly desired. Knowledge of and experience with the Common Fisheries Policy and/or International Ocean Governance would be an advantage. Excellent knowledge of English and good knowledge of French are required.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AD.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be that of a new published competition or already planned in the field. If there is none, recruitment will be at the level of AD5. The Authority authorised to conclude Contracts of Employment ('AACE') may grant a grade AD6 or AD7 based on an assessment of the needs of the service, including without limitation the nature of the profile sought, the level of responsibility to be exercised or the labour market conditions for the profile in question, and on the duration of the candidates' previous appropriate professional experience. The maximum recruitment grade is AD8, which may be granted under very exceptional circumstances.

The duration of the **1st contract will be of 1 to 3 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service. The duration of the extension will be defined according to the General Implementation Rules in force at that moment, in accordance with [Commission Decision C\(2013\)9049](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
