STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers **non-permanent** positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Directorate-General for Communication (DG COMM), as a corporate communication service, promotes the policy priorities of the European Commission and contributes to bringing Europe closer to the citizens. The Representations in all Member States play a crucial role in this. Their main tasks are:

- Support the President and the Members of the Commission by reinforcing the political and media profile of the European Commission in the Member States, including the preparation, organisation and follow up of visits of the members of the College. Representing the European Commission in the respective Member State towards national, regional and local authorities, media, stakeholders and citizens.
- Country-specific Economic and Political Information and Analysis: Representations provide the Commission with in-depth, accurate and timely information and analysis regarding relevant developments in the Member States and the views of the Government and, political parties, think tanks and civil society.
- Press and Media Communications: in cooperation with the Spokesperson's Service, Representations communicate on behalf of the Commission.
- Outreach to Citizens: Representations provide outreach and communication to citizens and stakeholders/multipliers in the Member States, by managing information networks and by explaining the policy priorities of the Commission in a local context.

WE PROPOSE

DG COMM is seeking to hire a Financial Agent in its Representation in Vienna, Austria.

The position will consist of a comprehensive set of responsibilities in the areas of budget, finance, contracts and accounting, ensuring the smooth and compliant functioning of administrative and financial operations. The role includes carrying out and following up on financial transactions such as commitments, purchase orders, fund reservations, payments, and VAT-related operations, as well as preparing and monitoring both specific and framework contracts. The postholder will contribute to inventory management and actively participate in the planning, implementation, and



monitoring of budgetary programming, particularly regarding administrative expenditures. Furthermore, the position supports the operational teams of the Representation in the preparation, management, and follow-up of calls for tenders and proposals, ensuring the correct application of procedures and compliance with eligibility, selection, and award criteria. This includes participation in the opening and evaluation of tenders and proposals, as well as the follow-up of procurement and grant procedures and assistance in managing contracts and agreements.

WE LOOK FOR

We are looking for a motivated and detail-oriented administrative professional with a strong interest in financial and budget management, as well as procurement, and with an excellent knowledge of the German language. The ideal candidate is capable of working in a structured and methodical way, ensuring compliance with rules and procedures, while supporting the operational teams of the Representation in administrative, financial, budgetary and contract-related processes. The position requires a high level of reliability, discretion, and the ability to manage multiple tasks in a dynamic environment, as well as a proactive approach to problem-solving and teamwork.

The ideal candidate has a strong professional experience in administration. An experience in monitoring budgetary management, public procurement, checking financial documentation or contract management is highly desirable, preferably within a public administration or international organisation. A good understanding of financial and administrative procedures, as well as experience in applying rules related to procurement and budgetary management, is considered an asset. The candidate should demonstrate strong organisational and analytical skills, attention to detail, and the ability to handle confidential information with discretion. Excellent communication and interpersonal skills are essential, along with the capacity to work both independently and collaboratively in a multicultural environment. Proficiency in standard IT tools such as MS Office is required, and knowledge of EU financial and budgetary procedures would be a strong advantage.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU¹
- AND have a satisfactory knowledge (minimum level B2)² of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from the EPSO database³ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in German and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission

➤ **Type of contract and working conditions**

The place of employment will be in **Vienna, Austria**.

The successful candidate will be engaged as a **contract agent under Article 3(a) of the [Conditions of Employment of Other Servants](#), in function group FG III**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the first contract will be 3 years. Possible consecutive extensions of 5 years and then indefinite duration are subject to an assessment of the staffing situation of Representations at that time.

Contract agents recruited in Function Group III have to successfully complete a 9-month probationary period.
