STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [**temporary agents**](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [**contract agents**](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG Trade and Economic Security is in charge of leading the EU's common commercial policy, one of the exclusive competences of the EU. Trade policy plays a critical role in enhancing the EU's economic competitiveness, shaping globalisation, and defending the EU from unfair trade practices and threats to its economic security.

Within the Directorate E, Unit TRADE.E.4 "Trade and Industrial Policy", develops, negotiates and implements EU rules, instruments and policies at the intersection of trade and industrial policy with a view to contributing to the global competitiveness and economic security of the European Union.

The Unit is responsible for trade aspects of all industrial sectors (automotives, aerospace, biotech, chemicals, energy intensive industries, pharmaceuticals, textiles etc.) including energy and net zero industry sectors as well as (critical) raw materials. The unit also acts as a focal point for coordination inside DG TRADE and with other Commission services on technology and trade related matters, notably regarding EU industries in the field of enabling and emerging high-tech technologies (such as semiconductors) and equipment.

The Unit is composed of a dynamic and motivated team with gender balance and wide geographical origins. This includes two secretaries, who are a central part of the team, and whose support and guidance is highly appreciated by all colleagues.



WE PROPOSE

We propose an interesting Secretary position, with varied tasks, in a pleasant and cooperative working environment with an excellent team spirit. The successful candidate will work as a secretary to the Head of Unit and will provide secretarial support to the Deputy Head of Unit and unit members as required. Working in the unit's two-person secretariat, the successful candidate will support the administration of the unit and carry out logistical tasks. This will involve everyday secretarial responsibilities, such as handling external contacts, the preparation and organization of meetings and missions, document management and monitoring deadlines. S/he will also take care of administrative handling of briefings, inter-service consultations, access to document requests, parliamentary questions, and similar procedures. In addition, s/he will assist the policy officers with standard ARES procedures in relation to the handling of notes, letters, reports and other correspondence.

WE LOOK FOR

We are seeking a dynamic and well-organised secretary with the ability to work both as part of a team and independently. The successful candidate should have a strong sense of initiative, responsibility, discretion, along with excellent interpersonal and organisational skills.

The candidate should have very good written and verbal communication skills in English. Good knowledge of French would be an asset. S/he should also have practical knowledge of the Commission's administrative procedures and IT tools such as ARES, MIPS, SYSPER, BASIS, DECIDE and V-PASS.

The position may occasionally require flexibility in working hours and office attendance.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), AST/SC.**

³ Officials from the Commission or other Institutions are invited to use the standard channels (Sysper or inter-institutional vacancy portal).



➤ Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
