STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions.. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

BUDG R2 is the unit of DG Budget, responsible for the design, implementation, and evolution of SUMMA, the Corporate Financial & Accounting Information System used by the Commission and currently 32 other EU institutions, bodies and agencies. This key digital solution offers efficient and streamlined financial processes built on the state-of-the-art SAP technology to all financial actors and major corporate systems.

The unit leads the SUMMA programme in line with DG Budget strategic objectives and organizes its governance, in close cooperation with all the units of BUDG.R directorate, and internal and external partners. The comprehensive work plan defined until 2030 includes the onboarding of around 30 other EU entities, leveraging further the efficiency, effectiveness and economy of financial processes with technological innovation such as AI and cloud, and ensuring alignment with the new MFF and evolving business requirements.

The unit employs 17 staff in 2 sectors working with teams of service providers. The programme is organized in horizontal governance bodies and cross-functional project teams with members of different units and directorates.

WE PROPOSE

Unit BUDG.R.2 Corporate Financial and Accounting Systems proposes a position of Administrative Agent. The position consists of managing the secretariat of the unit, assisting the Head of Unit as well as the other members of the Unit's management team, in the administration of the activities.

The main tasks will include:

- Agenda management, meetings organization
- Coordination and support in the preparation of meetings, workshops, and other events
- Administrative support in the management of the unit's resources and contracts (including onboarding of service providers) and related financial operations



- Support in production, filing and retrieval of documents (Ares, SharePoint online)
- Monitoring deadlines and workflows
- Contributing to administrative quality checks and preparation of files for the Head of Unit for approval/signature
- Management of mission's organisation for the Head of Unit and members of the Unit's management team
- Management of incoming and outgoing official correspondence (Ares) and units' mailboxes

Depending on the selected candidate's profile and background, the position could also extend to tasks of Programme Management assistance.

WE LOOK FOR

We are looking for a dynamic and organised colleague, with experience in managing administrative tasks and in providing assistance and support to management teams. Experience in the financial domain, IT literacy and project management support will be an advantage for this position.

The selected candidate will be a quick learner, who will be able to integrate the European Commission's work environment and become operational swiftly.

Previous work experience of at least 2 years in a similar role or related domain is required. High autonomy, sense of initiative, flexibility and service-oriented approach will also be essential characteristics. Prior experience in the European Commission will be an advantage. Excellent written and spoken knowledge of English is essential, as well as mastering the main office tools like Word, Excel, PowerPoint, Outlook. Good working knowledge of French is highly desirable.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of post-secondary education attested by a diploma OR
- (b) a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The selecting unit chooses from the EPSO database⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best

candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG II**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times, up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group II must successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
