STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Asset Management Unit in Directorate General for Financial Stability, Financial Services and Capital Markets Union (FISMA) manages the regulatory frameworks applicable to investment funds in the EU. The unit is responsible for the following:

- the development and implementation of the regulatory frameworks applicable to investment funds in the EU within the Capital Markets Union initiative, such as the review of the Alternative Investment Funds Manager Directive (AIFMD) and Directive on Undertakings for collective investment in transferable securities (UCITS), and review of the European Long Term Investment Funds (ELTIF) framework;
- the review of the consumer protection and transparency rules for retail investment products set out in the Packaged Retail and Insurance-based Investment Products (PRIIPs) framework, as part of the Commission's Retail Investment Strategy;
- The monitoring of wider financial stability aspects relevant for the fund sector and the implementation of rules for Money-Market funds (MMFs);
- The development and implementation of the EU's legislative agenda on sustainable finance, such as on the EU Green Bond Standard (EU GBS) and the implementation of the Sustainable Finance Disclosure Regulation (SFDR).

The Unit is responsible for the work relating to the European Union's fund frameworks including preparing and adopting level 2 rules and maintaining contacts with Member States, the European Parliament and the European Securities and Markets Authority (ESMA). The Unit is in constant contact with the stakeholders from the fund industry and environmental and consumer organisations.

WE PROPOSE

We offer an interesting and rewarding job in a hard-working, friendly team of 15 members, with a strong emphasis on collaboration and teamwork. The job involves mainly secretarial support to the unit members and the management.



Tasks include the following:

- organise meetings,
- prepare missions,
- manage the functional mailbox and follow-up incoming and outgoing mails,
- manage and filter phone calls,
- manage the unit's MS Teams group and Sharepoint Online Site,
- coordinate and monitor requests, replies to letter and deadlines,
- manage the agendas for group events,
- proof-read, format and edit notes and letters,
- manage documents, ensure the circulation of documents,
- assist on adoption and decision-making procedures,
- organise the Unit's social events and internal communication,
- assist with the HR management of the Unit (e.g. HR issues, annual leave and time management, job descriptions, etc.).

WE LOOK FOR

We look for a motivated, well-organised and reliable colleague with relevant professional experience in secretarial support, a good sense of initiative and responsibility, an ability to work with a positive and flexible attitude, eager to make a difference in helping the unit delivering high quality and timely outputs. An excellent team spirit, with a service-oriented and solution-driven mindset, is essential. The candidate should be able to work both independently and within a team, should have strong attention to details and ability to perform multiple tasks and adjust to changing priorities.

Excellent interpersonal skills and ability to maintain and develop good relations with colleagues inside and outside the unit will be essential. Very good oral and written communication skills in English are indispensable. Knowledge of French would be an asset.

She/he should have an adequate professional training and/or experience in working with the Commission administrative IT tools (ARES, BASIS, MiPS, SYSPER, MIRA, ATMOS, V-pass, DECIDE, MS Office, MS Teams, Sharepoint Online, M365, WebDOR). Prior experience in administrative and organisational tasks is required.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language (French).

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
