STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

DG COMP's Unit I5 is a dynamic unit of 23 people, in charge of developing and implementing DG Competition's (DG COMP) communication strategy. We provide a wide range of communication services to the Directorate-General, the Executive Vice-President and her Cabinet.

This includes external communication (outreach events, workshops and conferences, the DG COMP public website, social media, press activities, production of audiovisual material and publications) as well as internal communication (intranet site, internal news, organisation of internal events). In addition to these communication actions, our Unit is also in charge of coordinating briefings for the EVP, the President and DG COMP's senior management members.

We also are responsible for DG COMP's Knowledge Management, the DG's library, and we assist with research of information in the preparation of competition cases. Our team culture is built on personal commitment, accountability, collaboration, trust, and flexibility.

WE PROPOSE

The Directorate-General for Competition seeking an Administrative Assistant (AST/SC) for Unit I5 supporting the briefings and press coordination teams and contributing to the continuity and day-to-day functioning of the unit. The post offers an interesting job opportunity for colleagues that would like to combine administrative and operational tasks.

The selected candidate will assist the briefings team (coordinating and consolidating contributions from case teams) to deliver briefings on competition matters. She/he will also assist the press team coordinating the



production of press materials on competition matters, including the management of the press planner. This means working closely with colleagues across the DG, the Cabinet, the Secretariat-General and other DGs.

The jobholder will also assist colleagues in other punctual tasks linked with the organization of internal and external events, including managing functional mailboxes, document registration and filing. The post offers an opportunity to work closely with several colleagues across the unit and to develop progressively in areas related to internal and external communications.

WE LOOK FOR

We are looking for a colleague with excellent communications and organisational skills, who has a good eye for detail, can handle short deadlines and is a true team player. A communications background and an excellent command of English are essential. Prior experience in briefings coordination, press and information tasks would be an advantage. Understanding of Competition Policy instruments and concepts is a strong advantage to effectively communicate on our files, and to be able to work on specialised briefings, press and communications activities.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English/French and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ **Type of contract and working conditions**

The place of employment will be Brussels.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST/SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
