STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- **[temporary agents](#)** are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- **[contract agents](#)** may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit COMP F.3 is responsible for State aid control in a wide range of sectors, including postal services, healthcare, housing, gambling, education, culture, and maritime and road transport. The unit also leads general policy on Services of General Economic Interest (SGEI), in particular the SGEI package, with a recent focus on affordable housing and critical medicines following the revision of the SGEI Decision adopted in December 2025. In addition, the unit contributes to State aid policy development and initiatives as part of the wider State Aid Network within DG COMP, whose mission is to develop and enforce State aid control in the EU.

WE PROPOSE

A position as case handler in a friendly and team-oriented working environment. The selected officer will work in case teams of lawyers and economists and will take, together with the case managers, responsibility for a portfolio of State aid cases across the sectors covered by Unit F.3, including postal services, healthcare, housing, gambling, education, culture, and maritime and road transport.

A distinctive feature of the Unit's work is that undertakings in these sectors frequently operate under public service obligations and may receive compensation from the State under Article 106(2) TFEU. Beyond standard State aid assessment, the daily work therefore involves close engagement with the SGEI rules.

The work is dynamic and varied: the economic and legal assessment of notifications by Member States and of complaints from competitors, which are particularly common in F.3; drafting the corresponding decisions until their adoption by the Commission; and assisting the Legal Service in defending these decisions before the European Courts. Extensive contacts within and outside the Commission — with public authorities, undertakings and their advisers — are a constant feature of the job.



WE LOOK FOR

A dynamic professional with a strong background in economics, ideally with professional experience in State aid law and policy, and in particular in the assessment of public service obligations under the SGEI rules and Article 106(2) TFEU. The ability to apply rigorous economic analysis to complex State aid cases is essential. Familiarity with sectors covered by the Unit — such as postal services, healthcare, housing, gambling, education, culture, maritime, or road transport — would be an asset; knowledge of State aid and SGEI rules as they apply to the housing sector would be particularly welcome. The candidate should be able to communicate clearly, and very good drafting skills in English are essential. The ideal candidate combines team spirit with the initiative to work independently, sometimes under tight deadlines.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least a level of education which corresponds to completed university studies of at least 3 years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function groups AD.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be of 1 to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
