STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The Publications Office of the European Union is the official provider of publishing services to all EU institutions, bodies, and agencies. As such, it is the central point of access to EU law, and also to publications, data, research results, procurement notices and other official information. The Publications Office therefore plays a central role in informing the public about what the EU does and means for them, and in unlocking the power of data.

Its mission is to support EU policies as a centre of excellence for data, information and knowledge management, and to ensure that this broad range of information is available to the public as accessible and reusable data to facilitate transparency, economic activity and the diffusion of knowledge.

The Office publishes in all the official languages of the European Union and continuously adapts its services to a rapidly evolving technological environment (e.g. data services, cloud computing, machine learning and artificial intelligence).

The Directorate C 'Access to and Reuse of Public Information' manages the key dissemination services that ensure authoritative access to and reuse of EU law and legal information, public procurement information, open public data and the results of EU-funded research and innovation projects. These services are based on the following thematic portals:

- EUR-Lex (EU law),
- TED (EU public procurement),
- data.europa.eu, the official portal for European Data,
- CORDIS (EU research results).

Unit C1 "European Data and Related Services" is responsible for the management and business development of the European Data Portal, data.europa.eu. The unit provides an end-to-end service, which includes content creation; management and dissemination, while taking into account usability, reusability, accessibility, availability, performance and reliability.

The unit is responsible for the Publications Office's strategic objective "European Open Data Space". The vacancy is in the sector Open Data Services (OP.C.1.002), which is managing the European Data Portal that provides access to open public data produced by EU institutions, agencies and bodies, in implementing the Commission Decision 2011/833/EU on the reuse of Commission documents. It harvests the metadata of Public Sector Information available on public data portals across European countries, international organisations and EU research projects. It provides access to over 200 national data and geospatial catalogues and produces and publishes reports and studies about open data and related subjects to increase the open data literacy and value. Moreover, the service ensures the business development in order to provide



data publishers, application developers, reusers and the public with new services and functionalities. It manages projects in the area of data visualisation and linked open data and represents the Publications Office in interservice committees in the data domain.

WE PROPOSE

We propose a challenging and rewarding position as Knowledge Management Assistant. You will be part of a small but dynamic and highly motivated team responsible for the overall development of the open data services and platform.

Your tasks and responsibilities will involve:

- contributing to the overall development of the European Data Portal and connected services;
- initiating and implementing projects in the area of open data and linked open data assigned for implementation to the Publications Office and fostering the interoperability and interlinking of open data with other sources of public sector information;
- overseeing the work of contractors and their fulfilment of objectives and quality of deliverables, including organising testing of the deliverables;
- contributing to the development of new services based on EU open data and to solutions supporting interoperability and the implementation of standards-driven publishing among data providers;
- liaising with data providers, as well with other stakeholders and with representatives of the open data communities and Member States.

WE LOOK FOR

We look for a dynamic and highly motivated colleague to provide effective and proactive contributions in the areas of reuse and open data.

In terms of competencies and skills, you will:

- have experience in IT project management and follow up of quality for outsourced projects;
- have knowledge of data base management, metadata and search;
- have strong contract and budget management skills;
- have a strong logical and methodological working approach;
- have excellent capacity to act upon problems and propose workable solutions;
- have the skills to conceptualise and structure information, in particular technical and specialised one;
- have good oral and written communication skills (EN/FR) in order to communicate efficiently and fluently with internal and external partners and stakeholders and know how to get information to people clearly and effectively;
- have the ability to work to tight deadlines and to respond swiftly and effectively to unforeseen situations;
- be proactive, have a sense of initiative,
- be resilient;
- be a good team player.

An interest in Open data and FAIR principles as well as knowledge and experience in reuse policy are an advantage.

Experience in project management is essential.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least:

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Luxembourg**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group AST.**

➤ Grade

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
