STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit HR.DS.3's mission is to ensure a high level of technical and physical security in all Commission premises in Belgium and Luxembourg. In particular, the Unit is responsible for:

- Installation and maintenance of technical security systems and equipment.
- Access control and issuance of access cards.
- Information technology of security systems.
- Global security projects.
- Implementing infrastructure-based security improvements.

HR.DS.3 is currently composed of around 60 colleagues across Brussels and Luxembourg.

WE PROPOSE

HR.DS.3.002 is seeking to hire one security agent.

The position will consist of supporting the administrative and operational activities of the Technical Security team.

The jobholder will play a key role in supporting the administrative and technical monitoring of maintenance operations of technical security equipment by contractors.

This involves day-to-day use of the dedicated Computerised Maintenance Management System (CMMS) and the actual identification of the technical security equipment installed, thereby contributing to the quality and reliability of the data recorded in the system.

The jobholder will also prepare operational reports and performance indicators based on CMMS data, including maintenance activities, equipment malfunctions and maintenance working hours. The jobholder will contribute to inventory management, while working closely with colleagues and external contractors to support the efficient day-to-day operation of the service.



WE LOOK FOR

We are looking for a reliable, organised and service-oriented colleague who can take pride in ensuring a structured system of maintenance operations and inventory management, in the area of security.

The jobholder should be confident in working with information systems and administrative processes, be methodical in his/her approach, have excellent attention to detail and a strong ability to follow established procedures.

The jobholder should be willing to support colleagues and to contribute to the continuous improvement of data quality and business processes. Previous experience with maintenance management systems, asset management, facilities management or similar applications would be considered an asset. The jobholder should be able to organise the workload, manage competing priorities and ensure that requests are processed accurately and within the required deadlines.

It is required to have good analytical skills and to identify inconsistencies in data, propose practical solutions and prepare clear reports based on operational information. Effective communication with colleagues, contractors and other stakeholders is a must and also enjoying work as part of a team. The jobholder must be willing to provide support to others and to be able to explain procedures in a clear and practical manner.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and French and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission. Candidates are required to undergo a security vetting that is conducted with the national administration of the Member State.

➤ **Type of contract and working conditions**

The place of employment will be **Brussels**

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b)/2(d) of the [Conditions of Employment of Other Servants](#), in function group SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
