STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

The mission of the Innovation & Strategic Autonomy Unit is to foster an agile, competitive and autonomous technology base to support an area of freedom, security and justice without internal borders. The team finances, builds and deploys core European capabilities. We shape the policy framework that allows an EU market for those capabilities to emerge in a sustainable way and limiting non-European critical dependencies.

WE PROPOSE

We propose a position in a friendly and stimulating work environment dealing with innovative security technologies and financial instruments. The Unit interacts daily with a significant number of Commission services and Union agencies, as well as with Member States and external stakeholders and experts.

As part of the team, the chosen candidate will develop and implement financial and regulatory policies strengthening the Union's strategic autonomy in the area of science, innovation and technologies supporting an area of freedom, security and justice without internal frontiers. A particularly significant task is the preparation for the implementation of the new European Competitiveness Fund and Horizon Europe, in conjunction with appropriate measures with respect to security procurement, SME support, venture capital, advanced research projects, technology transfer and retention and industry cooperation.

The Legal and Policy Officer will provide legal analysis and advice in support of the implementation of Horizon Europe and the European Competitiveness Fund, and liaise with all relevant Commission services and implementing bodies. In addition, (s)he will advise on all legal and security matters related to strategic autonomy and technological sovereignty.



WE LOOK FOR

We are looking for a Legal and Policy Officer with a strong interest in security technology and innovation. The ideal candidate will have a legal background and be able to demonstrate, through previous professional experience, a solid understanding of the challenges connected, on the one hand, with the management and implementation of the Multiannual Financial Framework and, on the other hand, with the creation and maintenance of an area of freedom, security and justice without internal frontiers. The successful candidate must also demonstrate the ability to engage positively with a wide range of stakeholders in the fields of security, innovation and investment

The candidate must demonstrate a sufficient understanding of the Union's financial and investment framework, and preferably specifically also of security-related EU funding instruments. S/he must demonstrate experience or the capacity to integrate in a security sensitive working environment.

The candidate should be proactive and have good analytical and problem-solving skills. S/he should be able to develop increasing understanding of security challenges and capabilities needed to help ensure the continued safety and security of all Europeans, in a rapidly evolving technological and geopolitical landscape.

S/he must contribute to the positive work environment in the Unit. An excellent knowledge of English (written and oral) is required.

HOW TO EXPRESS YOUR INTEREST?

With a view to guaranteeing equal access to all, the Commission recruits from an open database of spontaneous applications. The present call for interests aims at helping the recruiters to identify potentially interested candidates within this database.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a contract agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen;
- Have fulfilled any obligations imposed by applicable laws concerning military service;
- Are physically fit to perform the duties linked to the position;
- Produce the appropriate character references as to suitability for the performance of the duties.
- Have passed an EPSO CAST in the relevant Function Group for this position. At the stage of the application, it is sufficient to be registered in the [EPSO CAST](#) data base.

Qualifications:

- (a) Have a level of education which corresponds to completed university studies of at least three years attested by a diploma.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted.

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND have a satisfactory knowledge (minimum level B2)³ of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ **What about the selection steps?**

The selecting unit chooses from [the EPSO database](#)⁴ candidates with the appropriate profile and invites them to an interview. For the interview a selection panel is set-up to assess the best candidates. Due to the large volume of applications that we may receive only candidates selected for the interview will be notified.

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in a second official language.

2. Recruitment

The candidate selected for recruitment will be requested to provide documentary evidence in support of the statements made in the database and, where relevant, the call for interest.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up carried out by the Commission. Candidates will be required to undergo a security vetting that is conducted with the national administration of the Member State.

➤ Type of contract and working conditions

The place of employment will be in **Brussels**.

The successful candidate will be engaged as a **contract agent under Article 3(b) of the [Conditions of Employment of Other Servants](#), in function group FG IV**. General information on Contract Agents can be found at this link.

The grade or proposed grade range, as well as the step in that grade, will be defined on the basis of the candidates' previous professional experience, in accordance with [Commission Decision C\(2017\)6760](#) laying down the criteria applicable to classification in step on engagement.

The duration of the **first contract will be 1 year**. Subject to the interest of the service, the contract may be renewed one or more times up to a maximum duration of 6 years.

The duration of the renewal(s) will be defined according to the General Implementing Rules in force at that moment (currently, [Commission Decision C\(2017\)6760](#) on policies for the engagement and use of contract agents).

Contract agents recruited in Function Group IV have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
