STAFF RECRUITED ON CONTRACTS

In addition to permanent officials, the European Commission offers non-permanent positions. There are two categories of non-permanent staff:

- [temporary agents](#) are recruited to fill vacant positions for a set amount of time or to perform highly specialised tasks.
- [contract agents](#) may provide additional capacity in specialised fields where an insufficient number of officials is available or carry out a number of administrative or manual tasks. They are generally recruited for fixed-term contracts (maximum 6 years in any EU Institution), but in some cases they can be offered contracts for an indefinite duration (in offices, agencies, delegations or representations).

WE ARE

Unit A4 (communication and inter-institutional relations) is at the heart of DG ECFIN's efforts to communicate on the Commission's economic policies to stakeholders, the public, and other EU institutions. As part of Directorate A, also in charge of DG ECFIN policy coordination, legal affairs, and the economic forecast, we are a cohesive, committed, and creative team tasked to promote, explain, and engage on DG ECFIN's main policy initiatives and activities, using a wide range of communication tools, from press work to innovative web and social media content, major events, a stakeholder outreach programme and academic publications.

We contribute to keeping ECFIN staff informed and engaged through a series of internal communication actions, ranging from intranet content to midday information sessions and other internal events.

We also coordinate DG ECFIN's relations with the European Parliament, the Economic and Social Committee, the Committee of the Regions, the Ombudsman and National Parliaments. The unit consists of 23 colleagues of 14 nationalities, who work in a very good team spirit, coordinating closely across 6 teams: press and media, web and social media, events and stakeholder outreach, publications, internal communication, and inter institutional relations.

WE PROPOSE

We propose an interesting and rewarding job in a friendly, professional, and dynamic unit with a strong focus on cooperation, teamwork and creativity. In addition to supporting the Head of Unit and other unit members, you will have the opportunity to take initiatives, contribute to external and internal communication projects, and to develop contacts with interlocutors across DG ECFIN and beyond. The tasks of the job also include coordinating the reply to citizens' questions and complaints and the unit's contribution to other communication and inter-institutional workstreams.



Tasks include:

- providing support to the Head of Unit in the management of the unit - assisting the Head of Unit with personnel administration (e.g., HR issues, training requests, annual leave and time management, job descriptions and recruitment)
- coordinating reporting exercises
- managing the documents and correspondence addressed to the unit, including reception, registration, assignments within unit, and follow-up, filing and archiving of documents, and management of unit shared drives, as well as access-to-document requests
- providing support to the organisation of communication activities, in particular events and internal communication activities such as the very popular Midday Info sessions
- managing missions and organising external and internal meetings
- handling and coordinating replies to citizens' questions and complaints.

WE LOOK FOR

We look for a well-organised, pro-active colleague who can work both independently and as part of a team. If you have a sense of initiative, good planning skills, attention to detail and a strong team spirit, and if you like to work in a creative and dynamic environment, you will quickly integrate and enjoy working in our unit.

Good communication and social skills are important, as the unit has regular contacts with other Commission services and external stakeholders. The successful candidate would be familiar with IT tools (Word, Excel, Power Point and Sharepoint) and be open to adopt opportunities brought by the development of artificial intelligence. A good knowledge of the administrative procedures of the Commission, including IT-based tools (ARES, Sysper, MIPS, Basis, etc) would be an asset. A very good command of spoken and written English is essential. Knowledge of French or other languages would be an asset.

ANNEX

1. Selection

➤ Am I eligible to apply?

You must meet the following eligibility criteria when you validate your application:

Our rules provide that you can only be recruited as a temporary agent at the European Commission if you:

General criteria:

- Are a citizen of a Member State of the EU and enjoy full rights as a citizen
- Have fulfilled any obligations imposed by applicable laws concerning military service
- Are physically fit to perform the duties linked to the post
- Produce the appropriate character references as to suitability for the performance of the duties.

Qualifications:

FOR AST and AST/SC jobs: In order to be recruited for this position, you must have at least

- a level of post-secondary education attested by a diploma, or
- a level of secondary education attested by a diploma giving access to post-secondary education, and appropriate professional experience of at least three years.

Only qualifications issued or recognised as equivalent by EU Member State authorities (e.g. by the Ministry of Education) will be accepted. Furthermore, before recruitment, you will be required to provide the documents that corroborate the eligibility criteria (diplomas, certificates and other supporting documents).

Languages:

- have a thorough knowledge (minimum level C1) of one of the 24 official languages of the EU²
- AND a satisfactory knowledge (minimum level B2) of a second official language of the EU, to the extent necessary for the performance of the duties.

➤ What about the selection steps?

The post was published internally within the Commission, inter-institutionally, and brought to the attention of competition laureates.

² The official languages of the European Union are: BG (Bulgarian), CS (Czech), DA (Danish), DE (German), EL (Greek), EN (English), ES (Spanish), ET (Estonian), FI (Finnish), FR (French), GA (Irish), HR (Croatian), HU (Hungarian), IT (Italian), LT (Lithuanian), LV (Latvian), MT (Maltese), NL (Dutch), PL (Polish), PT (Portuguese), RO (Romanian), SK (Slovak), SL (Slovenian), SV (Swedish).



In accordance with Article 29 of the Staff Regulations, applications from Commission officials, officials from other Institutions, and laureates of competitions have priority³. If these candidates do not best fit the requirements for the position, the Commission can recruit a temporary agent.

For temporary agents under Article 2(a) of the [Conditions of Employment of Other Servants](#), the post is published directly on the EPSO website, without mandatory prior internal publication.

A selection panel will choose a limited number of candidates for interview, based on the CV and application form that they submitted. Due to the large volume of applications, we may receive, **only candidates selected for the next step of the selection phase will be notified.**

For operational reasons and in order to complete the selection procedure as quickly as possible in the interest of the candidates and of the institution, the selection procedure will be carried out in English and possibly in another language.

2. Recruitment

The candidate selected for recruitment will be requested to supply documentary evidence in support of the statements made in their application.

The successful candidate will be required to undergo a mandatory pre-recruitment medical check-up, carried out by the Commission.

➤ Type of contract and working conditions

The place of employment will be **Brussels**.

In case the successful candidate is not an official or a competition laureate, they will be recruited as a **temporary agent under Article 2(b) of the [Conditions of Employment of Other Servants](#), in function group SC.**

➤ **Grade**

The recruitment grade, as well as the step in that grade, will be determined in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents and with [Commission Decision C\(2013\)8970](#) laying down the criteria applicable to classification in step on engagement.

The recruitment grade will be calculated based on the qualifications and the number of years of professional experience, according to Art. 13 of the Commission Decision C(2025)4716. Higher grades may be granted exceptionally.

In principle, The duration of the **1st contract will be up to 4 years**. The contract might then be extended only once for a maximum of 2 years and in the interest of service, in accordance with [Commission Decision C\(2025\)4716](#) on policies for the engagement and use of temporary agents.

All new staff have to successfully complete a 9-month probationary period.

The pay of staff members consists of a basic salary supplemented with specific allowances, including, where applicable, expatriation and family allowances. The provisions guiding the calculation of these allowances can be consulted in the Conditions of Employment of Other Servants. As a member of staff of the European institutions, your pay is subject to a tax raised by those institutions.

The European Commission applies a policy of equal opportunities and non-discrimination in accordance with Article 1d of the Staff Regulations.
