Information regarding your application

Dear Candidate,

On Friday, 1 March 2024, EPSO [will reopen the application period for the Transport competition](#) to which you have already applied successfully. This is necessary in view of the fact that EPSO is moving towards a full 24 language regime for its selection procedures, as of 2024. We invite you to read EPSO's communiqué of 6 February 2024, for more information on this matter: [EPSO selection procedures – towards a full 24 language regime | EU Careers \(europa.eu\)](#). New interested people will also be able to apply.

As regards the competition of which you are currently a candidate, the following are the main changes that you must be made aware of:

- All selection tests will be made available in 24 languages;
- Candidates must choose **2 languages** for their selection tests;
- Your previous choice of languages will be **deleted**;
- The case study is replaced by a **written test** focusing on written communication skills assessed under a specific new set of anchors (these anchors will be published on EPSO's website in due time).

In view of the above, **you must choose again your languages. You will also be given the possibility of editing your current application form, by, for instance, adding new information** (e.g. education, professional experience) since you last filled this form. You will be able to do so as of 1 March 2024. Please understand that you are not obliged to edit your application form if you do not wish to introduce any changes, but you can amend it if you wish. However – and this is **VERY IMPORTANT** – **you must validate your application form once again**, even if you have not made any changes to it, if you wish to remain a candidate in the competition. **New**

deadline for the validation of your application: 9 April 2024 at 12.00 (midday), Brussels time.

The deadline to submit supporting documents will also change: 4 June 2024 at 12.00 (midday), Brussels time.

As soon as EPSO reopens the application period on 1 March 2024, **this letter will disappear from your EPSO Account** due to the system's setup (EPSO regrets this technical inconvenience). For that reason, EPSO will send you a copy of this letter to the e-mail address in your EPSO Account and will also publish it on the competition's dedicated webpage [Administrators in the field of transport | EU Careers \(europa.eu\)](#) under the section **Important documents**. Please check your EPSO Account and update the e-mail address if necessary.
